DETERMINATION UNDER SECTION 170A (4) (a) OF THE CRIMINAL PROCEDURE ACT, 1977 (ACT No. 51 OF 1977), OF THE PERSONS OR THE CATEGORIES OR CLASSES OF PERSONS WHO ARE COMPETENT TO BE APPOINTED AS INTERMEDIARIES

Under section 170A (4) (a) of the Criminal Procedure Act, 1977 (Act No. 51 of 1977), I, Abdulah Mohamed Omar, Minister of Justice, hereby amend Government Notice No. R. 1374 of 30 July 1993, by the substitution for paragraph (f) of the following paragraph:

- "(f) Educators in terms of the Educators' Employment Act, 1994 (Proclamation No. 138 of 1994), who have four years' experience in teaching and who have not at any stage, for whatever reason, been suspended or dismissed from service in teaching."
