### ASSIGNMENT TO THE PROVINCES OF CERTAIN PROVISIONS OF THE SECTIONAL TITLES ACT, 1986, UNDER ITEM 14 OF SCHEDULE 6 TO THE CONSTITUTION OF THE REPUBLIC OF SOUTH AFRICA, 1996

Under item 14 (1) of Schedule 6 to the Constitution of the Republic of South Africa, 1996 (Act No. 108 of 1996), I hereby assign sections 1 (4), 4 (10), 20 (2), 24 (2), 25 (7), and 26 (3) of the Sectional Titles Act, 1986 (Act No. 95 of 1986), to an authority within a provincial executive designated by the Executive Council of each of the provinces mentioned in section 103 (1) of the Constitution.

 AMENDMENT OF THE SECOND SCHEDULE TO THE ACT**

Under the powers vested in me by section 1 (2) of the Atmospheric Pollution Prevention Act, 1965 (Act No. 45 of 1965), Zweledinga Pallo Jordan, Minister of Environmental Affairs and Tourism, hereby amend, with effect from the date of publication hereof, the Second Schedule to the Act—

(a) by the substitution for item 14 of the following item:

**"14. Hydrocarbon refining processes:**

That is to say—

- (a) the processing (such as distilling, cracking and refining) of crude shale oil, crude petroleum, natural gas, hydrocarbons from coal and used lubricating oils; or
- (b) the bulk storage of crude petroleum and liquid petroleum products, in storage facilities with individual tank capacities of at least 1 000 cubic metres each.";

(b) by the substitution, in item 34, for the heading of the following heading:

**"34. Gas, coke and charcoal processes:";**

(c) by the substitution for item 44 of the following item:

**"44. Hydrogen cyanide processes:**

That is to say, processes in which—

- (a) hydrogen cyanide is made, or any chemical manufacturing process in which hydrogen cyanide is evolved or used; or
- (b) solid sodium or calcium cyanide is made."; and

(d) by the addition of the following item:

**“72. Vinyl chloride monomer processes:**

That is to say, processes in which vinyl chloride monomer is manufactured or used.”.

**REGULATIONS GOVERNING THE LABELLING AND ADVERTISING OF FOODSTUFFS: AMENDMENT**

The Minister of Health has, in terms of section 15 (1) of the Foodstuffs, Cosmetics and Disinfectants Act, 1972 (Act No. 54 of 1972), made the regulations in the Schedule.

**SCHEDULE**

1. In this Schedule “the Regulations” means the regulations published under Government Notice No. R. 2034 of 29 October 1993, as amended by Government Notice No. R. 129 of 2 February 1996.

**Amendment of Annex 3 of the Regulations**

2. Annex 3 of the Regulations is hereby amended by—

- (a) the substitution, opposite the nutrient “Vitamin A”, for the unit of measurement “ $\mu\text{g RE}$ ” of “ $\mu\text{g retinol}$ ”; and

(b) the substitution for footnote 1 of the following:

"1 µg retinol = 1 retinol equivalent (RE) = 6 µg trans-B-carotene = 12 µg other provitamin carotenoids = 3,33 IU (international units) vitamin A = 10 IU provitamin A carotenoids."
