ANNEXURE

For general information it is hereby notified that the President has, under the powers vested in him by section 41 (1) of the Public Service Act, 1994, issued the following regulations:

The Public Service Regulations, published under Government Notice No. R. 1091 of 10 June 1994, as amended, are hereby further amended by—

- (a) the substitution of the existing heading of regulation A20 with the following heading:
“Salary increments that may be granted to personnel who were remunerated according to personal salary scales on 30 June 1996 and who were not translated to the standard salary ranges of the salary grading system;”;
- (b) the insertion of the following paragraph as a new subregulation A20.1:
“A20.1 The provisions of subregulations 2 to 9 are only applicable to personnel who were in service on 30 June 1996 and remain in service and who were on the above-mentioned date remunerated according to personal salary scales and who were not translated to the standard salary ranges of the salary grading system and who are therefore still remunerated according to the personal salary scales which applied to them on 30 June 1996.”; and
- (c) the subsequent renumbering of the existing subregulations A20.1 to A20.9 and the renumbering of references within these subregulations to other subregulations.

BYLAE

Vir algemene inligting word hiermee bekendgemaak dat die President, kragtens die bevoegdhede aan hom verleen in artikel 41 (1) van die Staatsdienswet, 1994, die volgende regulasies uitgevaardig het:

Die Staatsdiensregulasies gepubliseer in Goewermentskennisgewing No. R. 1091 van 10 Junie 1994, soos gewysig, word hierby verder gewysig deur—

- (a) die vervanging van die bestaande opskrif van regulasie A20 met die volgende opskrif:
“Salarisverhogings wat toegestaan mag word aan personeel wat op 30 Junie 1996 volgens persoonlike salarisskale besoldig is en wat nie na die standaard salarisreekse van die salarisgraderingstelsel oorgeskakel is nie.”;
- (b) die invoeging van die volgende paragraaf as 'n nuwe subregulasie A20.1:
“A20.1 Die bepalings van subregulasies 2 tot 9 is slegs van toepassing op die personeel wat op 30 Junie 1996 in diens was en nog steeds is en wat op gemelde datum volgens persoonlike salarisskale besoldig is en wat nie na die standaard salarisreekse van die salarisgraderingstelsel oorgeskakel het nie en wat gevolglik nog steeds volgens die persoonlike salarisskale wat op 30 Junie 1996 op hulle van toepassing was, besoldig word.”; en
- (c) die gevolglike hernoemering van die bestaande subregulasies A20.1 tot A20.9 en die hernoemering van die verwysings binne hierdie subregulasies na ander subregulasies.
