DETERMINATION OF MAGISTRATES' SALARIES FOR THE PURPOSES OF THE MAGISTRATES ACT, 1993

I, Abdulah Mohamed Omar, Minister of Justice, acting under section 12 (1) of the Magistrates Act, 1993 (Act No. 90 of 1993), hereby determine that—

- (1) the motor car financing benefit of a chief magistrate in terms of paragraph 3 (1) of the Schedule to Government Notice No. R. 1149 of 30 July 1996 is the motor car financing benefit, including the requirements, conditions, circumstances and bases of calculations, which is applicable to a director in the Public Service from 1 July 1996 and 1 October 1996; and
- (2) the motor car financing benefit of a regional court president and a special grade chief magistrate in terms of paragraph 3 (2) of the Schedule to Government Notice No. R. 1149 of 30 July 1996 is the motor car financing benefit, including the requirements, conditions, circumstances and bases of calculations, which is applicable to a chief director in the Public Service from 1 July 1996 and 1 October 1996.
