#### AMENDMENT OF THE CLOSE CORPORATIONS ADMINISTRATIVE REGULATIONS, 1984

I, Alexander Erwin, Minister of Trade and Industry, hereby, under section 10 of the Close Corporations Act, 1984 (Act No. 69 of 1984), amend the Close Corporations Administrative Regulations, 1984, published under Government Notice No. R. 2487 of 1984, in accordance with the Schedule hereto.

#### SCHEDULE

The Close Corporations Administrative Regulations, 1984, are hereby amended—

- (a) by the repeal of regulation 14A;
- (b) by the substitution for subregulation (5) of regulation 15 of the following subregulation:

“(5) Form CK7 containing particulars of the name reserved for the corporation, as approved by the Registrar, together with such other Forms CK7, if any, containing particulars of the translated name and of the shortened form of the name or translated name, for the corporation, as approved by the Registrar, shall be attached to Form CK1.”; and

- (c) by the substitution for subregulation (6) of regulation 16 of the following subregulation:

“(6) If the name or translated name of a corporation or the shortened form of a corporation's name or translated name is to be changed, the Form CK7 containing the new name of the corporation, as approved by the Registrar, together with such other Forms CK7, as the case may be, containing the new translated name or the shortened form of the corporation's name or translated name as approved by the Registrar, shall be attached to Form CK2.”.

## BYLAE

Die Administratiewe Regulasies vir Beslote Korporasies, 1984, word hierby gewysig—

- (a) deur regulasie 14A te herroep;
- (b) deur subregulasie (5) van regulasie 15 deur die volgende subregulasie te vervang:
- “(5) Vorm CK7 wat besonderhede bevat van die naam wat vir die korporasie gereserveer is, soos deur die Registrateur goedgekeur, saam met sodanige ander Vorms CK7, as daar is, wat besonderhede bevat van die vertaalde naam en verkorte vorm van die naam of vertaalde naam vir die korporasie, soos deur die Registrateur goedgekeur, moet by Vorm CK1 aangeheg word.”; en
- (c) deur subregulasie (6) van regulasie 16 deur die volgende subregulasie te vervang:
- “(6) Indien die naam of vertaalde naam van 'n korporasie of die verkorte vorm van die korporasie se naam of vertaalde naam verander gaan word, moet Vorm CK7 wat die nuwe naam van die korporasie bevat, soos deur die Registrateur goedgekeur, saam met sodanige ander Vorms CK7 wat, na gelang van die geval, die nuwe vertaalde naam of verkorte vorm van die korporasie se naam of vertaalde naam bevat wat deur die Registrateur goedgekeur is, by Vorm CK2 aangeheg word.”.
