LIQUOR PRODUCTS ACT, 1989 (ACT NO. 60 OF 1989)

REGULATIONS: AMENDMENT

The Minister of Agriculture has, under section 27 of the Liquor Products Act, 1989 (Act No. 60 of 1989), made the regulations in the Schedule.

SCHEDULE

Definition

- In these regulations "the Regulations" means the regulations published by Government Notice No. R. 1433 of 29 June 1990, as amended by Government Notices Nos. R. 838 of 19 April 1991, R. 2841 of 29 November 1991, R. 2079 of 24 July 1992, R. 2593 of 11 September 1992, R. 2791 of 2 October 1992, R. 3152 of 20 November 1992, R. 1376 of 30 July 1993, R. 2350 of 10 December 1993, R. 356 of 25 February 1994, R. 636 of 8 April 1994, R. 1022 of 27 May 1994, R. 2242 of 23 December 1994, R. 394 of 17 March 1995, R. 1695 of 3 November 1995, R. 1876 of 8 December 1995 and R. 501 of 29 March 1996.

Amendment of regulation 53 of the Regulations

2. Regulation 53 of the Regulations is hereby amended by the substitution for the subregulations (1) and (2) of the following subregulations:

"(1) An export certificate shall—

- (a) in the case of a product that was sampled in terms of regulation 52, be issued only if—
 - (i) the results of the analysis referred to in regulation 52 (6) indicate that the product concerned is a liquor product or, if not, the applicant concerned satisfies the administering officer that such other product may be sold for drinking purposes in the country to which it is to be exported; and
 - (ii) the board has, on the basis of the sensorial judgement of the sample of the product concerned found that product to be suitable for export; and
 - (b) in the case of wine intended for export to the European Union in respect of which it is claimed that it consist of two cultivars, be issued only if the administering officer has been convinced that the wine concerned was obtained exclusively from the two cultivars concerned.
- (2) A liquor product shall be found unsuitable in terms of subregulation (1) (a) (ii) only if the board is of the opinion that the sample of that product reveals sensorially unacceptable quality characteristics."

REGULASIES: WYSIGING

Die Minister van Landbou het kragtens artikel 27 van die Wet op Drankprodukte, 1989 (Wet No. 60 van 1989), die regulasies in die Bylae uitgevaardig.

BYLAE**Woordomskrywing**

1. In hierdie Bylae beteken "die Regulasies" die regulasies gepubliseer by Goewermentskennisgewing No. R. 1433 van 29 Junie 1990, soos gewysig deur Goewermentskennisgewings Nos. R. 838 van 19 April 1991, R. 2841 van 29 November 1991, R. 2079 van 24 Julie 1992, R. 2593 van 11 September 1992, R. 2791 van 2 Oktober 1992, R. 3152 van 20 November 1992, R. 1376 van 30 Julie 1993, R. 2350 van 10 Desember 1993, R. 356 van 25 Februarie 1994, R. 636 van 8 April 1994, R. 1022 van 27 Mei 1994, R. 2242 van 23 Desember 1994, R. 394 van 17 Maart 1995, R. 1695 van 3 November 1995, R. 1876 van 8 Desember 1995 en R. 501 van 29 Maart 1996.

Wysiging van regulasie 53 van die Regulasies

2. Regulasie 53 van die Regulasies word hierby gewysig deur subregulasie (1) en (2) deur die volgende subregulasies te vervang:

"(1) 'n Uitvoersertifikaat word—

- (a) in die geval van 'n produk wat ingevolge regulasie 52 bemonster is, slegs uitgereik indien
 - (i) die resultate van die ontleding in regulasie 52 (6) bedoel, aantoon dat die betrokke produk 'n drankproduk is of, indien nie, die betrokke aansoeker die beherende amptenaar tevrede stel dat so 'n ander produk vir drinkdoeleindes verkoop mag word in die land waarheen dit uitgevoer staan te word; en
 - (ii) die raad op grond van die sintuiglike beoordeling van die monster van die betrokke produk, daardie produk as geskik vir uitvoer bevind het; en
 - (b) in die geval van wyn bestem vir uitvoer na die Europese Unie ten opsigte waarvan aanspraak gemaak word dat dit uit twee cultivars bestaan, slegs uitgereik indien die beherende amptenaar oortuig word dat die betrokke wyn uitsluitlik van die betrokke twee cultivars verkry is.
- (2) 'n Drankproduk word slegs ingevolge subregulasie (1) (a) (ii) ongeskik vir uitvoer bevind indien die raad van oordeel is dat die monster van daardie produk sintuiglik—onaanvaarbare gehalte-eienskappe openbaar."
