CO-OPERATIVES ACT, 1981 (No. 91 OF 1981)

SCHEDULE**Definitions**

1. In these regulations any word or expression to which a meaning has been assigned in the Act, shall have that meaning, and—

- (a) "the Act" means the Co-operatives Act, 1981 (Act No. 91 of 1981); and
- (b) "the regulations" means the regulations published by the Government Notice No. R. 230 of 9 July 1993.

Amendment of Annexure 1 of the Regulations

2. Annexure 1 of the regulations is hereby amended by the deletion of the words following after footnote (1) and which read as follows:

"N.B. The documents mentioned in (b), (d) and (e) must be signed by the chairman of the formation meeting and the schedule in (f) by the chairman and secretary of the co-operative."
