ROAD TRAFFIC ACT, 1989 (ACT No. 29 OF 1989)

COMING INTO OPERATION OF CERTAIN REGULATIONS OF THE ROAD TRAFFIC REGULATIONS IN RESPECT OF CERTAIN REGISTERING AUTHORITIES

I, Sathyandranath Ragunanan Maharaj, Minister of Transport, acting under—

(a) regulation 35 (a) of the Tenth Amendment of the Road Traffic Regulations as published by Government Notice No. R. 3172 of 20 November 1992 as amended by regulation 13 of the Eleventh Amendment of the Road Traffic Regulations as published by Government Notice No. R. 766 of 30 April 1993, and regulation 41 of the Fourteenth Amendment of the Road Traffic Regulations as published by Government Notice No. R. 1878 of 18 October 1993, hereby determine—

- (i) 6 October 1997 for the registering authorities of Klerksdorp, Stilfontein, Wolmaransstad, Bloemhof, Orkney, Ottosdal, Hartbeesfontein and Leeudoringstad;
- (ii) 20 October 1997 for the registering authorities of Lichtenburg, Coligny, Sannieshof, Zeerust, Potchefstroom, Ventersdorp and Fochville;
- (iii) 10 November 1997 for the registering authorities of Delareyville, Christiana and Schweizer-Reneke;
- (iv) 1 December 1997 for the registering authorities of Rustenburg, Swartruggens, Koster and Brits,

as the date upon which regulation 10 of the said Tenth Amendment of the Road Traffic Regulations, in so far as it—

- (aa) amends regulations 175 to 228 and regulations 236 to 238 of the Road Traffic Regulations;
- and

- (bb) inserts regulations 238A to 238U of the Road Traffic Regulations, comes into operation in respect of the registering authorities referred to in subparagraphs (i) to (iv).
- (b) regulation 50 (1) (g) of the Twenty Second Amendment of the Road Traffic Regulations as published by Government Notice No. R. 926 of 30 June 1995, as amended by regulation 28 of the Twenty Seventh Amendment of the Road Traffic Regulations as published by Government Notice No. R. 1076 of 28 June 1996, hereby determine—
- (i) 6 October 1997 for the registering authorities of Klerksdorp, Stilfontein, Wolmaransstad, Bloemhof, Orkney, Ottosdal, Hartbeesfontein and Leeudoringstad;
 - (ii) 20 October 1997 for the registering authorities of Lichtenburg, Coligny, Sannieshof, Zeerust, Potchefstroom, Ventersdorp and Fochville;
 - (iii) 10 November 1997 for the registering authorities of Delareyville, Christiana and Schweizer-Reneke;
 - (iv) 1 December 1997 for the registering authorities of Rustenburg, Swartruggens, Koster and Brits,
- as the date upon which regulations 42 (b), 42 (f) and 49 of the said Twenty Second Amendment of the Road Traffic Regulations come into operation in respect of the registering authorities referred to in subparagraphs (i) to (iv).

- (i) 6 Oktober 1997 vir die registrasie-owerhede van Klerksdorp, Stilfontein, Wolmaransstad, Bloemhof, Orkney, Ottosdal, Hartbeesfontein en Leeudoringstad;

- (ii) 20 Oktober 1997 vir die registrasie-owerhede van Lichtenburg, Coligny, Sannieshof, Zeerust, Potchefstroom, Ventersdorp en Fochville;
- (iii) 10 November 1997 vir die registrasie-owerhede van Delareyville, Christiana en Schweizer-Reneke;
- (iv) 1 Desember 1997 vir die registrasie-owerhede van Rustenburg, Swartruggens, Koster en Brits,
