SEA FISHERY ACT, 1988 (ACT NO. 12 OF 1988)

AMENDMENT OF REGULATIONS

The Minister of Environmental Affairs and Tourism has, after consultation with the Sea Fishery Advisory Committee, under section 45 of the Sea Fishery Act, 1988 (Act No. 12 of 1988), amended the regulations promulgated in terms of the said Act, as set out in the Schedule.

SCHEDULE

1. "The Regulations" means the regulations published under Government Notice No. R. 2934 dated 23 October 1992, and amended by Government Notices No. R. 3248 of 27 November 1992, No. R. 5 of 8 January 1993, No. R. 1052 of 18 June 1993, No. R. 2003 of 15 October 1993, No. R. 2228 of 17 November 1993, No. R. 2556 of 31 December 1993, No. R. 656 of 8 April 1994 and No. R. 1371 of 12 August 1994, No. R. 987 dated 30 June 1995, No. R. 1073 dated 21 July 1995, No. R. 1644 dated 27 October 1995, No. R. 1026 dated 21 June 1996, No. R. 1371 dated 23 August 1996 and No. R. 604 dated 25 April 1997.

2. Regulation 43 of the Regulations is hereby amended by the insertion after subparagraph (g) of the following subparagraph:

"(h) squid, also known as chokka (*Loligo vulgaris reynaudii*)—25 October to 22 November in any year, both dates inclusive."

3. Regulation 47 of the Regulations is hereby amended by—
- the insertion in subregulation (1) of the words "Sawfishes (*Pristidae*)" after the words "Potato Bass (*Epinephelus tukula*)";
 - the insertion in subregulation (5) of the words "Sawfishes (*Pristidae*)" after the words "Red steenbras (*Polysteganus undulosus*)".
4. Regulation 47A of the Regulations is hereby substituted for the following regulation:
- 47A. No person shall, except under the authority of a permit issued by the director-general and subject to the conditions determined by the director-general in the permit, catch, attempt to catch, land, sell, offer for sale or be in possession of the following species:
- Orange Roughy [*Hoplostethus spp.* including *H. atlanticus* and *H. mediterraneus* (silver roughy)];
- Oreo Dories (family *Oreosomatidae* including *Pseudocyttus maculatus*, *Allocyttus niger*, *A. verrucosus*, *A. quineensis*, *Neocytus rhomboidalis* and *Oreosoma atlanticum*);
- Alfonsino [family *Berycidae* including *Beryx splendens* (alfonsino) and *B. decadactylus* (long-finned beryx)];
- Patagonian Toothfish (*Dissostichus eleginoides* and *Dissostichus mawsonii*);
- Cardinal fishes (deep-water cardinals) (subfamily *Epigonidae*); and
- Wreckfish (*Polypriion americanus*)."

WET OP SEEVISSERY, 1988 (WET NO. 12 VAN 1988)

WYSIGING VAN REGULASIES

Die Minister van Omgewingsake en Toerisme het, na oorleg met die Seevisseryadvieskomitee, kragtens artikel 45 van die Wet op Seevissery, 1988 (Wet No. 12 van 1988), die Regulasies uitgevaardig kragtens genoemde Wet, gewysig soos in die Bylae uiteengesit.

BYLAE

1. "Die Regulasies" beteken die Regulasies afgekondig by Goewermentskennisgewing No. R. 2934 gedateer 23 Oktober 1992, soos gewysig by Goewermentskennisgewings No. R. 3248 van 27 November 1992, No. R. 5 van 8 Januarie 1993, No. R. 1052 van 18 Junie 1993, No. R. 2003 van 15 Oktober 1993, No. R. 2228 van 17 November 1993, No. R. 2556 van 31 Desember 1993, No. R. 656 van 8 April 1994 en No. R. 1371 van 12 Augustus 1994, No. R. 987 van 30 Junie 1995, No. R. 1073 van 21 Julie 1995, No. R. 1644 van 27 Oktober 1995 en No. R. 1026 van 21 Junie 1996; No. R. 1371 van 23 Augustus 1996 en No. R. 604 van 25 April 1997.

2. Regulasie 43 van die Regulasies word hierby gewysig deur die invoeging van die volgende subparagraph na subparagraph (g):

(h) tjokka, (*Loligo vulgaris reynaudii*)—25 Oktober tot 22 November van enige jaar beide datums ingesluit.”.

3. Regulasie 47 van die regulasies word hierby gewysig deur—

- die invoeging in subregulasie (1) van die woord "Saagvis (*Pristidae*)" na die woord "Potato Bass (*Epinephelus tukula*)"; en
- die invoeging in subregulasie (5) van die woord "Saagvis (*Pristidae*)" na die woord "Rooisteenbras (*Polysteganus undulosus*)".

4. Regulasie 47A van die Regulasies word hierby deur die volgende regulasie vervang:

47A. Behalwe op gesag van 'n permit uitgereik deur die direkteur-generaal en onderworpe aan die voorwaardes deur hom in die permit bepaal mag niemand enige van die volgende spesies vang, probeer vang, aan land bring, verkoop, te koop aanbied of in besit daarvan wees nie:

Orange Roughy [*Hoplostethus spp.* met inbegrip van *H. atlanticus* en *H. mediterraneus* (silver roughy)];

Oreo Dories (familie *Oreosomatidae* met inbegrip van *Pseudocyttus maculatus*, *Allocyttus niger*, *A. verrucosus*, *A. quineensis*, *Neocytus rhomboidalis* en *Oreosoma atlanticum*);

Alfonsino Berikiede [familie *Berycidae* met inbegrip van *Beryx splendens* (alfonsino) en *B. decadactylus* (langvin beryx)];

Patagonian Toothfish (*Dissostichus eleginoides* en *Dissostichus mansonii*);

Kardinaalvisse (diepwater kardinale) (familie *Epigonidae*);

Wrakfis (*Polypriion americanus*).”.

REGULATIONS REGARDING THE REGISTRATION OF STUDENT SOCIAL WORKERS AND THE HOLDING OF DISCIPLINARY INQUIRIES: AMENDMENT

The Minister for Welfare and Population Development has, in terms of section 28 of the Social Work Act (Act No. 110 of 1978), on the recommendation of the South African Interim Council for Social Work, made the regulations set out in the Schedule hereto.

SCHEDULE

Definition

1. In this Schedule "the Regulations" shall mean the regulations published as Government Notice No. R. 2427 of 30 October 1987, as amended by Government Notices Nos. R. 952 of 3 May 1991 and R. 1826 of 1 October 1993.

Amendment of regulation 3

2. Regulation 3 of the Regulations is hereby amended by the insertion after paragraph (3) (b) of the following paragraph:
- "(c) Approval can be given to a social work student from a country, the area of which has never been part of the Republic, who wish to do his/her practical training at a training or any other institution in the Republic: Provided that such student—
- (i) submit documentary proof acceptable to the Council that he/she is enrolled for the subject Social Work at a training institution in his/her country of origin;
 - (ii) register with the Council as a student social worker; and
 - (iii) pay the prescribed registration fees.”.

Commencement

3. These regulations shall come into effect on the date of publication of this notice.



Wysiging van regulasie 3

2. Regulasie 3 van die Regulasies word hierby gewysig deur die volgende paragraaf na paragraaf (3) (b) in te voeg:
- "(c) Goedkeuring kan verleen word aan 'n maatskaplikewerk-student van 'n land waarvan die gebied nooit deel van die Republiek uitgemaak het nie om sy/haar praktykopleiding aan 'n opleidingsinrigting of enige ander instansie in die Republiek te doen: Met dien verstande dat sodanige student—
- (i) dokumentêre bewyse voorlê wat vir die Raad aanvaarbaar is dat hy/sy in sy/haar land van herkoms vir die vak Maatskaplike Werk aan 'n opleidingsinrigting ingeskryf is;
 - (ii) by die Raad registreer as 'n student-maatskaplike werker; en
 - (iii) die voorgeskrewe registrasiegeld betaal.”.
