ATTORNEYS ACT, 1979 (ACT NO. 53 OF 1979)

AMENDMENT OF REGULATIONS

The Minister of Justice has, under section 81 (2) of the Attorneys Act, 1979 (Act No. 53 of 1979), with the concurrence of the Chief Justice of South Africa and after consultation with the presidents of the various law societies, made the regulations in the Schedule.

SCHEDULE

Definition

1. 


Where is the largest amount of meteorological information in the whole of South Africa available?






