### AMENDMENT OF THE ROAD TRAFFIC REGULATIONS

The Minister of Transport has, under section 132 of the Road Traffic Act, 1989 ( Act No. 29 of 1989), made the regulations in the Schedule.

#### SCHEDULE

#### Definition

1. In this Schedule "the Regulations" means the Road Traffic Regulations published in Government Notice No. R. 910 of 26 April 1990, as amended by Government Notices Nos. ## **Amendment of regulation 240 of the Regulations**

2. Regulation 240 of the Regulations is amended—

(a) by the replacement of paragraph (b) of subregulation (2) by the following paragraph:

“(b) (i) The holder of a driver's licence that was issued before 1 March 1998, who wishes to substitute such licence as contemplated in section 24A of the Act, shall apply for such substitution within the period determined by the Minister by notice in the *Gazette*.

(ii) Different periods may be determined under subparagraph (i) in respect of licence holders whose surnames start with different letters of the alphabet, or whose dates of birth fall in different months.”; and

(b) by the insertion in subregulation (2) after paragraph (b) of the following paragraph:

“(c) A driver's licence that was issued before 1 March 1998 and which is contained in an identity document shall, after a date to be determined by the Minister by notice in the *Gazette*, be deemed not to be a valid document for the purpose of proof of the fact that the person is the holder of a driver's licence as contemplated in section 15 of the Act.”.

## **Replacement of regulation 438A of the Regulations**

3. Regulation 438A of the Regulations is replaced by the following regulation:

### **“Ascertainment of concentration of alcohol in breath**

**438A.** The equipment used to ascertain the concentration alcohol in any breath specimen as contemplated in section 122, must comply with the requirements of the standard specification SABS 1793 ‘Evidential breath testing equipment’.”.

## **Short title**

4. These regulations are called the Thirty Fifth amendment of the Road Traffic Regulations.

## **Woordomskrywing**

## **Wysiging van regulasie 240 van die Regulasies**

2. Regulasie 240 van die Regulasies word hierby gewysig—

(a) deur paragraaf (b) van subregulasie (2) deur die volgende paragraaf te vervang:

“(b) (i) Die houer van ’n bestuurderslisensie wat voor 1 Maart 1998 uitgereik is, wie sodanige lisensie wil vervang soos in artikel 24A van die Wet beoog, moet aansoek doen om sodanige vervanging binne die tydperk wat die Minister by kennisgewing in die *Staatskoerant* bepaal.

(ii) Verskillende tydperke kan kragtens subparagraaf (i) bepaal word ten opsigte van lisensiehouers wie se vanne met verskillende letters van die alfabet begin of wie se geboorte datums in verskillende maande val.”; en

(b) deur die volgende paragraaf na paragraaf (b) in subregulasie (2) in te voeg:

(c) ’n Bestuurderslisensie wat voor 1 Maart 1998 uitgereik is, en wat in ’n identiteitsdokument vervat is, word na ’n datum wat die Minister by kennisgewing in die *Staatskoerant* bepaal, geag nie ’n geldige dokument te wees vir die doeleindes om te bewys dat die persoon die houer is van ’n bestuurderslisensie soos in artikel 15 beoog nie.”.

## **Vervanging van regulasie 438A van die Regulasies**

3. Regulasie 438A van die Regulasies word hierby deur die volgende regulasie vervang:

### **“Vasstelling van konsentrasie alkohol in asem**

**438A.** Die toerusting wat gebruik word om die konsentrasie alkohol in enige asemmonster vas te stel soos beoog in artikel 122 van die Wet, moet voldoen aan die vereistes van die standaard spesifikasie SABS 1793 ‘Bewysasemtoetstoerusting’.”.

**ROAD TRAFFIC ACT, 1989 (ACT NO. 29 OF 1989)****DETERMINATION UNDER REGULATION 240(2)(B) OF THE ROAD TRAFFIC REGULATIONS OF THE PERIOD WITHIN WHICH A PERSON MUST APPLY FOR THE SUBSTITUTION OF A DRIVER'S LICENCE AS CONTEMPLATED IN SECTION 24A OF THE ROAD TRAFFIC ACT, 1989**

I, Satyandranath Ragunanan Maharaj, Minister of Transport, acting under regulation 240(2)(b) of the Road Traffic Regulations, hereby determine that if the date of birth of the holder of a driver's licence issued before 1 March 1998, falls within the month mentioned in the first column in the table below, the period mentioned against such month in the second column is the period within which such holder must apply for the substitution of such driver's licence as contemplated in section 24A of the Road Traffic Act, 1989 (Act No. 29 of 1989).

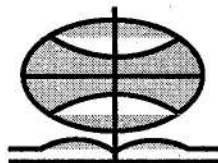

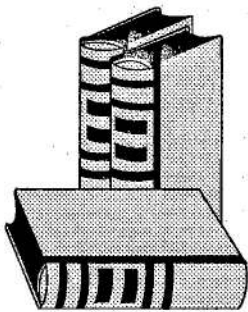
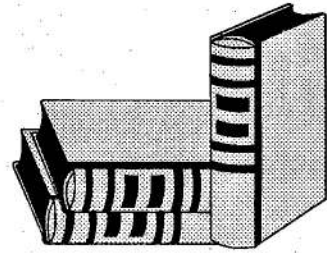
