## GOVERNMENT NOTICE GOEWERMENTSKENNISGEWING

### DEPARTMENT OF ENVIRONMENTAL AFFAIRS AND TOURISM DEPARTEMENT VAN OMGEWINGSAKE EN TOERISME

No. R. 354

6 March 1998

SEA FISHERY ACT, 1988 (ACT NO. 12 OF 1988)

#### AMENDMENT OF REGULATIONS

The minister of Environmental Affairs and Tourism has, after consultation with the Sea Fishery Advisory Committee, under section 45 of the Sea Fishery Act, 1988 (Act No. 12 of 1988), amended the regulations promulgated in terms of the said Act, as set out in the Schedule.

#### SCHEDULE

1. "The Regulations" means the Regulations published under Government Notice No. R. 1343 dated 1 November 1997, as amended, by Government Notice No. R. 260 dated 13 February 1998.
2. Regulation 44 of the Regulations is hereby amended by the insertion in subregulation (2) of the words "and only" between the words "day" and "on" and by the substitution for the word "any" of the letter "a".

**3.** Regulation 55 of the Regulations is hereby amended by the substitution in subregulation (2) for the words preceding paragraph (a) of the following words:

- "(2) A permit issued under subregulation (1) shall authorise the holder thereof to catch collect or land not more than four west coast rock lobster per day and only on a Saturday, Sunday and a public holiday between the hours 08:00 to 16:00 by means only of—".

**4.** Regulation 56A of the Regulations is hereby amended by the insertion of the following subregulation after subregulation (5):

- "(6) The holder of a permit issued in terms of subregulation (2) shall immediately mark his or her catch by—
- (a) pulling the plastic wire us provided by Sea Fisheries through on of the breathing holes of the abalone in such a manner that it forms a loop through the which is firmly the identification tag as provided by Sea Fisheries, must be affixed;
  - (b) firmly attaching the identification tag as provided by Sea Fisheries, around the upper part of the tail nearest to the carapace of the west coast rock lobster.
- (7) A person who has acquired abalone or rock lobster from a subsistence fisher shall not resell or otherwise trade such abalone or rock lobster and he may not remove the mark or tag from such abalone or rock lobster: Provided that the prohibition on the resale shall not apply in respect of a hotel or restaurant who serves cooked abalone or rock lobster for immediate consumption.”.

**WET OP SEEVISSERY, 1988 (WET NO. 12 VAN 1988)**

**WYSIGING VAN REGULASIES**

Die Minister van Omgewingsake en Toerisme, het na oorleg met die Advieskomitee, kragtens artikel 45 van die Wet op Seevisserij, 1988 (Wet No. 12 van 1988), die Regulasies uitgevaardig kragtens genoemde Wet, gewysig soos in die Bylae uiteengesit.

**BYLAE**

**1.** "Die Regulasies" beteken die Regulasies aangekondig deur Goewermentskennisgiving No. R. 1343 gedateer 1 November 1997, soos gewysig, deur Goewermentskennisgiving No. R. 260 van 13 Februarie 1998.

**2.** Regulasie 44 van die Regulasies word hierby gewysig deur in subregulasie (2) die woorde "en slegs" tussen die woorde "dag" en "op" in te voeg en die woorde "enige" met "n" te vervang.

**3.** Regulasie 55 van die Regulasies word hierby gewysig deur in subregulasie (2) die woorde wat paragraaf (a) voorafgegaan deur die volgende woorde te vervang:

- "(2) 'n Permit uitgereik ingevolge subregulasie (1) magtig die houer daarvan om hoogstens vier krewe per dag slegs op 'n Saterdag, Sondag en 'n openbare vakansiedag tussen die ure 08:00 tot 16:00 te vang, versamel of te land en mag slegs—".

**4.** Regulasie 56A van die Regulasies word hierby gewysig deur die invoeging van die volgende subregulasies na subregulasie (5):

- "(6) Die houer van 'n permit uitgereik kragtens subregulasie (2) moet sy of haar vangs onmiddellik merk deur—
- (a) die plastiekdraad soos verskaf deur Seevisserye, op so 'n wyse deur die asemhalingsgate van die perlemoen te trek dat dit 'n lus vorm waardeur die identifikasiemerke soos verskaf deur Seevisserye, stewig vasgeheg moet word;
  - (b) die identifikasiemerke soos verskaf deur Seevisserye, stewig om die boonste deel van die stert naaste aan die kopborsstuk van die weskuskreef, te heg.
- (7) 'n Persoon wat perlemoen of weskus kreef van 'n bestaansgrondslagvisser bekom het, mag nie sodanige perlemoen of weskuskreef herverkoop of andersins van die hand sit nie en hy mag ook nie die identifikasiemerke verwijder nie: Met dien verstande dat die herverkoop nie betrekking het op 'n hotel of restaurant wat perlemoen of weskuskreef in gaar vorm vir onmiddellik gebruik bedien nie.”.
