AMENDMENT TO THE GENERAL REGULATIONS FOR THE SOUTH AFRICAN NATIONAL DEFENCE FORCE AND THE RESERVE

The Minister of Defence has, in terms of section 87 (1) (f) of the Defence Act, 1957 (Act No. 44 of 1957), published the regulations in the Schedule.

SCHEDULE

DEFINITION

1. In this Schedule, "the Regulations" means Chapter VI of the General Regulations for the South Africa National Defence Force and the Reserve, published in Government Notice No. R. 2110 of 26 November 1971, as amended by Government Notices Nos. R. 1387 of 13 August 1976 and R. 965 of 20 May 1994.

AMENDMENT OF CHAPTER VI OF REGULATIONS

2. Chapter VI of the Regulations is hereby amended by the insertion of the following regulation after regulation 27:
- "27A. A member rendering voluntary service in terms of section 24bis or 44 (9) of the Defence Act, 1957, may be granted vacation leave with pay at a rate of two working days for every month uninterrupted service: Provided that—
- (a) such leave is limited accumulative and that such accumulated leave which has not been utilised prior to the completion of the period of service for which it was granted, expires; and

- (b) such accumulated leave is not discountable for cash.”.
3. This regulation shall be deemed to have come into operation on **1 August 1997**.

WOORDOMSKRYWING

1. In hierdie Bylae beteken “die Regulasies” Hoofstuk VI van die Algemene Regulasies vir die Suid-Afrikaanse Nasionale Weermag en die Reserwe, aangekondig by Goewermentskennisgewing No. R. 2110 van 26 November 1971, soos gewysig deur Goewermentskennisgewings Nos. R. 1387 van 13 Augustus 1976 en R. 965 van 20 Mei 1994.

WYSIGING VAN HOOFSTUK VI VAN REGULASIES

2. Hoofstuk VI van die Regulasies word hierby gewysig deur die volgende regulasie na regulasie 27 in te voeg:
- “27A. Aan 'n lid wat ingevolge artikel 24bis of 44 (9) van die Verdedigingswet, 1957, vrywillig diens doen kan vakansieverlof met besoldiging toegestaan word op 'n basis van twee werksdae vir elke ononderbroke maand diens: Met diens verstande dat—
- (a) sodanige verlof beperk oploopbaar is, en dat sodanige opgehoede verlof wat nie voor die verstryking van die dienstermy waarvoor dit toegestaan word, geneem word nie, verval; en
 - (b) sodanige opgehoede verlof nie in kontant verdiskonterbaar is nie.”.
3. Hierdie regulasie word geag in werking te getree het op **1 Augustus 1997**.
