BIRTHS AND DEATHS REGISTRATION ACT, 1992
(ACT NO. 51 OF 1992)

FOURTH AMENDMENT OF THE REGULATIONS ON THE REGISTRATION OF BIRTHS AND DEATHS, 1992

The Minister of Home Affairs has, under section 32 of the Births and Deaths Registration Act, 1992 (Act No. 51 of 1992), made the regulations in the Schedule.

SCHEDULE

Definitions

1.(1) In this Schedule "the Regulations" means the regulations published by Government Notice No. R. 2139 of 9 September 1992, as amended by Government Notice Nos. R. 1503 of 2 September 1994, R. 1635 of 11 October 1996 and R. 879 of 3 July 1998.

(2) In the Regulations any reference to an Annexure to the Regulations shall be construed as referring to an Annexure to the English text of the Regulations.

Insertion of regulation 8A in the Regulations

2. The following regulation is hereby inserted after regulation 8 of the Regulations:

"Insertion of natural father's particulars in birth register of child

8A. (1) An application referred to in section 11(4) shall be submitted to the Director-General in the form and contain substantially the information as set out in Annexure 11.

(2) If the Director-General is satisfied that the requirements of section 11(4) and (5) have been complied with the natural father's particulars as set out in part B of Annexure 11 shall be entered in the birth register of the child concerned.".

Insertion of Annexure 11 in the Regulations

3. The accompanying Annexure is hereby inserted after Annexure 10 of the Regulations.

Amendment of Index of Annexures to the Regulations

4. The Index of Annexures to the Regulations is hereby amended by the insertion after the item "Abridged death certificate" of the following item:

"Application for the insertion of natural father's particulars in the birth register of child Annexure 11 "

Short title and commencement

5. These regulations shall be called the Fourth Amendment of the Regulations on the Registration of Births and Deaths, 1992, and shall come into operation on 4 February 1999.

BYLAE

Woordomskrywings

1.(1) In hierdie Bylae beteken die uitdrukking "die Regulasies" die regulasies afgekondig by Goewermentskennisgewing No. R. 2139 van 9 September 1992, soos gewysig deur Goewermentskennisgewing Nos. R. 1503 van 2 September 1994, R. 1635 van 11 Oktober 1996 en R.879 van 3 Julie 1998.

(2) In die Regulasies word enige verwysing na 'n Aanhangsel tot die Regulasies uitgelê as verwysend na 'n Aanhangsel tot die Engelse teks van die Regulasies.

Invoeging van regulasie 8A in die Regulasies

2. Die volgende regulasie word hierby na regulasie 8 van die Regulasies ingevoeg:

"Invoeging van natuurlike vader se besonderhede in kind se geboorte-register

8A. (1) 'n Aansoek bedoel in artikel 11(4) moet aan die Direkteur-generaal verstrek word in die vorm en wesenlik die inligting soos uiteengesit in Aanhangsel 11 bevat.

(2) Indien die Direkteur-generaal tevrede is dat die vereistes van artikel 11(4) en (5) nagekom is, word die natuurlike vader se besonderhede soos uiteengesit in gedeelte B van Aanhangsel 11 in die kind se geboorteregister aangeteken.".

Invoeging van Aanhangsel 11 in die Regulasies

3. Die bygaande Aanhangsel word hierby na Aanhangsel 10 van die Regulasies ingevoeg.

Wysiging van Indeks van Aanhangsels tot die Regulasies.

4. Die Indeks van Aanhangsels tot die Regulasies word hierby gewysig in die mate soos in die Engelse teks van hierdie Regulasies uiteengesit.

Kort titel en inwerkingtreding

5. Hierdie regulasies heet die Vierde Wysiging van die Regulasies op die Registrasie van Geboortes en Sterftes, 1992, en tree in werking op 4 Februarie 1999.



