CUSTOMS AND EXCISE ACT, 1964

IMPOSITION OF PROVISIONAL PAYMENT (VB/71)

Under section 57A of the Customs and Excise Act, 1964, the provisional payment in relation to anti-dumping duty imposed in terms of Government Notice No. R. 1680 of 18 December 1998 on acetaminophenol originating in France is reduced from 101c/kg to 75c/kg **with retrospective effect to 18 December 1998.**
