LOCAL GOVERNMENT TRANSITION ACT, 1993 (ACT No. 209 OF 1993) AMENDMENT OF DISPENSING OF TENDER REGULATIONS

The Minister for Provincial Affairs and Constitutional Development has, after consultation with the MEC's, under section 12, read with section 10G(5)(c), of the Local Government Transition Act, 1993 (Act No. 209 of 1993), made the regulations in the Schedule.

SCHEDULE

Definitions

1. In these regulations a word or a phrase to which a meaning has been assigned in the Local Government Transition Act, 1993 (Act No. 209 of 1993), has that meaning and, unless the context otherwise indicates -

"the Regulations" means the Dispensing of Tender Regulations, 1998 (Government Notice No. R. 1224 of 2 October 1998).

Substitution of regulation 1 of the Regulations

2. The following regulation is hereby substituted for regulation 1 of the Regulations:

"Definitions

1. In these regulations a word or a phrase to which a meaning has been assigned in the Local Government Transition Act, 1993 (Act No. 209 of 1993), has that meaning and, unless the context otherwise indicates -

'category' means -

- (a) in respect of a municipality other than a district council, a category of municipality as determined in terms of item 3 of the Annexure; and
- (b) in respect of a district council, the category of the highest category of municipality within the area of jurisdiction of the district council in question;

'rates income' for the purpose of determining the category for a particular financial year, means the actual rates income of a municipality for the previous financial year as calculated by each municipality at the end of such previous financial year."

Amendment of regulation 2 of the Regulations

3. Regulation 2 of the Regulations is hereby amended-

(a) by the substitution for subparagraph (i) of paragraph (a) of the following subparagraph:

"(i) the amount involved or likely to be involved does not exceed in respect of-

- (aa) category 1 an amount of R50 000;
- (bb) category 2 an amount of R70 000; and
- (cc) category 3 an amount of R120 000,

provided that any municipality may determine a lower amount than the amount set for the category of that municipality by this subparagraph;";

- (b) by the deletion at the end of subparagraph (vi) of paragraph (a) of the word "or";
- (c) by the substitution for the word "and" at the end of subparagraph (vii) of paragraph (a) of the word "or"; and
- (d) by the addition to paragraph (a) of the following subparagraph:

"(viii) the execution of such work or the supply or sale of such goods or materials is so urgent that it would not be in the interest of the municipality to invite tenders; and".

Addition of Annexure to the Regulations

4. The following Annexure is hereby added after regulation 3 of the Regulations:

Determination of categories

3. The sum of the number of points allocated to a municipality in terms of items 1 and 2 respectively, determines the category of such municipality in accordance with the following table:

Category	Points
1	0 to 31.25
2	31.26 to 62.50
3	62.51 and above.

Omskrywings

Vervanging van regulasie 1 van die Regulasies

2. Regulasie 1 van die Regulasies word hierby deur die volgende regulasie vervang:

"Omskrywings

1. In hierdie regulasies het 'n woord of uitdrukking waaraan 'n betekenis in die Oorgangswet op Plaaslike Regering, 1993 (Wet No. 209 van 1993), toegeken is daardie betekenis, en tensy uit die samehang anders blyk, beteken -

'kategorie' -

- (a) ten opsigte van 'n munisipaliteit, buiten 'n distrikraad, 'n kategorie van munisipaliteit soos bepaal ingevolge item 3 van die Aanhangsel; en
- (b) ten opsigte van 'n distrikraad, die kategorie van die hoogste kategorie van munisipaliteit binne die regsgebied van die betrokke distrikraad;

'belasting-inkomste', vir doeleindes van die bepaling van die kategorie vir 'n bepaalde finansiële jaar, die werklike belasting-inkomste vir die vorige finansiële jaar, soos deur elke munisipaliteit aan die einde van sodanige vorige finansiële jaar bereken."

Wysiging van regulasie 2 van die Regulasies

3. Regulasie 2 van die Regulasies word hierby gewysig-

(a) deur subparagraaf (i) van paragraaf (a) deur die volgende sub-paragraaf te vervang:

"(i) die bedrag wat betrokke is of waarskynlik betrokke sal wees, nie ten opsigte van -

- (aa) kategorie 1 'n bedrag van R50 000;
- (bb) kategorie 2 'n bedrag van R70 000; en
- (cc) kategorie 3 'n bedrag van R120 000,

oorskry nie, met dien verstande dat 'n munisipaliteit 'n mindere bedrag kan bepaal as die bedrag wat ingevolge hierdie subparagraaf vir die kategorie van sodanige munisipaliteit vasgestel is;"

- (b) deur die woord "of" aan die einde van subparagraaf (vi) van paragraaf (a), te skrap;
- (c) deur die woord "en" aan die einde van subparagraaf (vii) van paragraaf (a) deur die woord "of" te vervang; en
- (d) deur die volgende subparagraaf by paragraaf (a) te voeg:

"(viii) die uitvoering van sodanige werk, of die verskaffing of verkoop van sodanige goedere of materiaal, so dringend is dat dit nie in die belang van die munisipaliteit sou wees om tenders aan te vra nie; en".


