### AMENDMENT OF REGULATIONS

#### *Definitions*

1. In this Schedule "the Regulations" means the regulations published by Government Notice No. R. 2490 of 28 December 1973, as amended by Government Notices Nos. R. 1424 of 11 July 1980, R. 1682 of 29 July 1983, R. 612 of 31 March 1989, R. 1922 of 17 August 1990 and R. 1542 of 13 August 1993.

#### *Repeal of regulation 22 of the Regulations*

2. Regulation 22 of the Regulations is hereby repealed.
