ENVIRONMENTAL CONSERVATION ACT, 1989 (ACT No. 73 OF 1989)

AMENDMENT NOTICE: THE IDENTIFICATION UNDER SECTION 21 OF ACTIVITIES WHICH MAY HAVE A SUBSTANTIAL DETRIMENTAL EFFECT ON THE ENVIRONMENT

I, Zweledinga Pallo Jordan, Minister of Environmental Affairs and Tourism, hereby amend Government Notice No. R. 1529 of 27 November 1998 by amending the description of the following properties included in the Umtamvuna Sensitive Coastal Area as reflected in Schedule 3 to the said Government Notice:

1. Banners Rest

- (a) The insertion of the figures "79; 80" after the figure "78"; and
- (b) the deletion of the figure "245".

2. Port Edward

- (a) The deletion of the figures "183; 184; 185"; and
- (b) the insertion after the figure "912" of the figure "925".

3. Glenmore

- (a) The substitution for the figures "68; 69" of the figures "67; 68; 69; 70; 71"; and
- (b) the deletion of the figure "769".
