### ELECTORAL COMMISSION

No. R. 705

#### AMENDMENT OF THE ELECTION REGULATIONS

The Electoral Commission has in terms of section 100 of the Electoral Act, 1998 (Act No. 73 of 1998), made the regulations set out in the Schedule.

**SCHEDULE****Definitions**

1. In these regulations "the Regulations" means the regulations published in Government Notice No. R. 478 of 14 April 1999.

**Amendment of regulation 43 of the Regulations**

2. Regulation 43 of the Regulations is hereby substituted by the following regulation:

"43. No agent or candidate may within the boundary of a voting station-

- (a) display or distribute any party billboard, poster, placard or pamphlet;
- (b) wear, carry or display any clothing, headwear, footwear or other apparel in such a manner that any writing, picture or sign thereon, relating to any political party is visible;
- (c) attempt to induce, influence or persuade a person to vote for or not to vote for a particular party; or
- (d) attempt to induce, influence or persuade a person not to vote.".

**Short title**

3. These regulations are called the **Second Amendment to the Election Regulations, 1999.**

Die Verkiesingskommissie het ingevolge artikel 100 van die Kieswet, 1998 (Wet No. 73 van 1998), die regulasies in die Bylae uiteengesit, uitgevaardig.

**BYLAE****Definisies**

1. In hierdie regulasies beteken "die Regulasies" die regulasies aangekondig in Gouvernetskennisgewing No. R. 478 van 14 April 1999.

**Wysiging van regulasie 43 van die Regulasies**

2. Regulasie 43 van die Regulasies word hierby deur die volgende regulasie vervang:

- "43. (1) Geen agent of kandidaat mag binne die grense van 'n stemlokaal-
- (a) enige partyreklamebord, biljet, plakkaat of pamflet vertoon of versprei nie;
  - (b) enige klerasie, hoofbedekking, voetbedekking of ander uitrusting aanhê, dra, of vertoon op so 'n wyse dat enige skrif, afbeelding of teken daarop, wat verband hou met enige politieke party, sigbaar is nie;
  - (c) poog om enige persoon oor te haal, te beïnvloed of te oorreed om vir 'n besondere party te stem of nie te stem nie; of
  - (d) poog om 'n persoon oor te haal, te beïnvloed of te oorreed om nie te stem nie.

**Kort titel**

4. Hierdie regulasies heet die Tweede Wysiging op die Verkiesingsregulasies, 1999.
