## GOVERNMENT NOTICE GOEWERMENTSKENNISGEWING

DEPARTMENT OF WELFARE  
DEPARTEMENT VAN WELSYN

**No. R. 813**

**25 June 1999**

### **AMENDMENT: REGULATIONS UNDER THE SOCIAL ASSISTANCE ACT, 1992 (ACT NO 59 OF 1992)**

The Minister for Welfare and Population Development has, in terms of section 19 of the Social Assistance Act, 1992 (Act No. 59 of 1992), made the regulations set out in the Schedule hereto.

#### **SCHEDULE**

1. In these regulations "the Regulations" means the regulations published by Government Notice No. R.418 of 31 March 1998.

#### **Amendment of regulation 1 of the Regulations**

2. Regulation 1 of the Regulations is hereby amended by -
  - (a) the substitution for the definition of "identity document" of the following definition:

"identity document" means a bar-coded identity document bearing a 13-digit identity number issued in terms of the Identification Act, 1986 (Act No 72 of 1986);

- (b) the insertion after the definition of "**medical practitioner**" of the following definition:

"**personal income**" means income earned or received by the primary care giver and includes income earned or received by his or her spouse.

#### **Amendment of regulation 3 of the Regulations**

3. Regulation 3 of the Regulations is hereby amended by the deletion of paragraphs (f), (g) and (h) of subregulation (2).

#### **Amendment of regulation 9 of the Regulations**

4. Regulation 9 of the Regulations is hereby amended by -

- (a) the substitution for paragraph (a) of subregulation (1) of the following paragraph:

"(a) An identity document of the applicant and, where applicable, of his or her spouse, issued in the Republic of South Africa,";

- (b) the substitution for paragraph (a) of subregulation (3) of the following paragraph:

"(a) Proof of personal income of the applicant and, where applicable, of his or her spouse, which may be made by way of a sworn statement, if necessary,";

- (c) the deletion of paragraphs (c), (d) and (e) of subregulation (3).

- (d) the addition of the following subregulation:

"(7) Notwithstanding the provisions of subregulation (6), any person in receipt of a grant shall, unless the Director-General directs otherwise, submit or cause to be submitted to the Director-General the following documents:

- (i) an identity document or a birth certificate bearing the 13-digit identity number of each child in respect of whom application for a grant was made; and
- (ii) his or her identity document and, where applicable, the identity document of his or her spouse, issued in the Republic of South Africa."

#### **Amendment of regulation 16 of the Regulations**

5. Regulation 16 of the Regulations is hereby amended by the substitution in subregulation (2) for the words preceding paragraph (i) of the following words:

"(2) A primary care giver shall qualify for the amount referred to in subregulation (1) if -  
his or her personal income is below -"

#### **Commencement**

6. These regulations shall come into effect on the date of publication of this notice.

**REGULASIES KRAGTENS DIE WET OP MAATSKAPLIKE BYSTAND, 1992  
(WET NO 59 VAN 1992): WYSIGING**

Die Minister vir Welsyn en Bevolkingsontwikkeling het, kragtens artikel 19 van die Wet op Maatskaplike Bystand, 1992 (Wet No. 59 van 1992), die regulasies in die Bylae hierin uiteengesit, uitgevaardig.

**BYLAE**

1. In hierdie regulasies, beteken "die Regulasies" die regulasies afgekondig by Goewermentskennisgewing No. R.418 van 31 Maart 1998.

**Wysiging van regulasie 1 van die Regulasies**

2. Regulasie 1 van die Regulasies word hierby gewysig -
- (a) deur die omskrywing van "**identiteitsdokument**" deur die volgende omskrywing te vervang:
- "identiteitsdokument"** 'n staafkode identiteitsdokument waarop die 13-syfer-identiteitsnommer voorkom uitgereik ingevolge die Identifikasiewet, 1986 (Wet No 72 van 1986);
- (b) deur na die omskrywing van "**maatskaplike werker**" die volgende omskrywing in te voeg:
- "persoonlike inkomste"** beteken inkomste verdien of ontvang deur die primêre versorger en sluit inkomste verdien of ontvang deur sy of haar gade in.

**Wysiging van regulasie 3 van die Regulasies**

3. Regulasie 3 van die Regulasies word hierby gewysig deur paragrawe (f), (g) en (h) van subregulasie (2) te skrap.

**Wysiging van regulasie 9 van die Regulasies**

4. Regulasie 9 van die Regulasies word hierby gewysig -
- (a) deur paragraaf (a) van subregulasie (1) deur die volgende paragraaf te vervang:
- "(a) 'n Identiteitsdokument van die applikant en, waar van toepassing, van sy of haar gade, uitgereik in die Republiek van Suid-Afrika,";
- (b) deur paragraaf (a) van subregulasie (3) deur die volgende paragraaf te vervang:
- "(a) Bewys van persoonlike inkomste van die applikant en, waar van toepassing, sy of haar gade wat, indien nodig, by wyse van 'n beëdigde verklaring gemaak kan word,";

(c) deur paragrawe (c), (d) en (e) van subregulasie (3) te skrap.

(d) deur die volgende subregulasie by te voeg:

“(7) Ondanks die bepalings van subregulasie (6) moet enige persoon in ontvangs van ‘n toelae, tensy die Direkteur-generaal anders bepaal, die volgende dokumente aan die Direkteur-generaal voorlê of laat voorlê:

- (i) ‘n identiteitsdokument of ‘n geboortesertifikaat waarop die 13-syfer-identiteitsnommer voorkom van elke kind ten opsigte van wie aansoek om ‘n toelae gedoen is;” en
- (ii) sy of haar identiteitsdokument en, waar van toepassing, die identiteitsdokument van sy of haar gade, uitgereik in die Republiek van Suid-Afrika.”.

### Wysiging van regulasie 16 van die Regulasies

5. Regulasie 16 van die Regulasies word hierby gewysig deur die woorde wat paragraaf (i) van subregulasie (2) voorafgaan, deur die volgende woorde te vervang:

“(2) ’n Primêre versorger kwalifiseer vir die bedrag bedoel in subregulasie (1) indien -  
sy of haar persoonlike inkomste minder is as -”

6. Hierdie regulasies tree op die datum van publikasie van hierdie kennisgewing in werking.
