LOCAL GOVERNMENT TRANSITION ACT, 1993 (ACT No. 209 OF 1993)

Y2K COMPLIANCE AMENDMENT REGULATIONS FOR MUNICIPALITIES

The Minister for Provincial and Local Government has, after consultation with the MEC's under section 12, read with sections 10G (1) and 10I of the Local Government Transition Act, 1993 (Act No. 209 of 1993), made the regulations in the Schedule.

SCHEDULE**Definitions**

1. In these regulations a word or phrase to which a meaning has been assigned in the Local Government Transition Act, 1993 (Act No. 209 of 1993), has that meaning and, unless the context otherwise indicates—

“the Regulations” means the Y2k Compliance Regulations, 1999 (Government Notice No. R. 254 of 25 February 1999).

Amendment of regulation 2 of Regulations

2. Regulation 2 of the Regulations is hereby amended—

- (a) by the substitution in subregulation (2) for the expression “30 April 2000” of the expression “30 June 1999”; and
- (b) by the addition of the following subregulation:

“(3) With effect from 30 July 1999, the chief executive officer of each municipality must on or before the 30th of each month submit to the head of the provincial department responsible for local government in the province concerned a completed report in the format contained in Annexure 2, until advised otherwise in writing by the head of such department.”.

Amendment of Regulations

3. The Regulations are hereby amended—

- (a) by the substitution for the expression “the Annexure”, wherever it occurs, of the expression “Annexure 1”; and
- (b) by the addition of the following Annexure, the existing Annexure becoming Annexure 1:

1. In hierdie regulasies het 'n woord of uitdrukking waaraan 'n betekenis in die Oorgangswet op Plaaslike Regering, 1993 (Wet No. 209 van 1993), toegeken is, daardie betekenis, en, tensy uit die samehang anders blyk, beteken—

“die Regulasies” die Y2k-Voldoening Regulasies, 1999 (Goewermentskennisgewing No. R. 254 van 25 Februarie 1999).

Wysiging van regulasie 2 van Regulasies

2. Regulasie 2 van die Regulasies word hierby gewysig—

- (a) deur in subregulasie (2) die uitdrukking “30 April 2000” deur die uitdrukking “30 Junie 1999” te vervang; en
- (b) deur die volgende subregulasie by te voeg:

“(3) Met ingang van 30 Julie 1999, moet die hoof uitvoerende beampte van elke munisipaliteit voor of op die 30ste van elke maand 'n voltooide verslag in die formaat soos in Aanhangsel 2 vervat, aan die hoof van die provinsiale departement wat vir plaaslike regering in die betrokke provinsie verantwoordelik is, voorlê, totdat die hoof van sodanige departement skriftelik anders laat weet.”.

Wysiging van Regulasies

3. Die Regulasies word hierby gewysig—

- (a) deur die uitdrukking “die Aanhangsel”, waar dit ookal voorkom, deur die uitdrukking “Aanhangsel 1” te vervang; en
- (b) deur die volgende Aanhangsel by te voeg, terwyl die bestaande Aanhangsel, Aanhangsel 1 word:

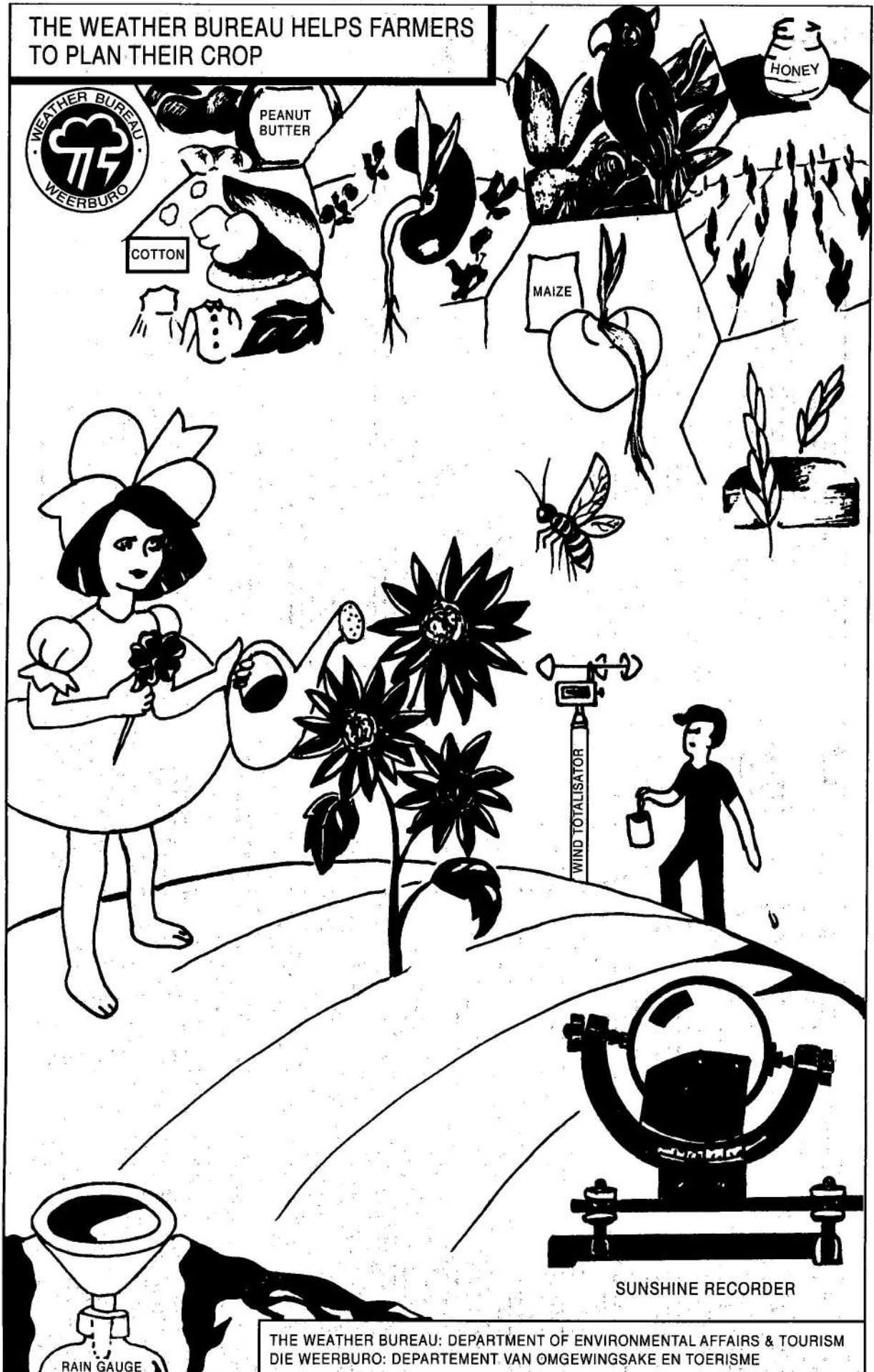
