## GOVERNMENT NOTICE

### **THE SOUTH AFRICAN MEDICINES AND MEDICAL DEVICES REGULATORY AUTHORITY ACT, 1998 (ACT No. 132 of 1998).**

In an appeal heard by the full bench of the Pretoria High Court, case number A819/99, lodged by:

1. The Pharmaceutical Manufacturers Association of South Africa as first Appellant; and
2. Crop Medical and Animal Health Association as second Appellant,

in re: The *ex parte* application of:

  4. The Chairperson, Medicines Control Council, Dr H Rees NO as fourth Applicant;
  5. The Minister of Agriculture, the honourable Mr D A Hannekom NO, as fifth Applicant;
  6. The Registrar, Fertilizers, Farmfeeds, Agricultural Remedies and Stock Remedies, Mr E Wolmarans NO, as the sixth Applicant;
  7. The Pharmaceutical Manufacturers Association of South African, as the seventh Applicant;
  8. Crop Protection and Animal Health Association, as the eighth Applicant,
- the Court has directed that the following order be published for general information:

#### ORDER

1. The appeal is allowed.
2. The order of the court *a quo* is set aside and substituted by the following order:
  - 2.1 proclamation No. R 49, 1999 in *Government Gazette* No. 6519 on 30 April 1999 is null and void and of no force or effect.
  - 2.2 Government Notice R567 published in *Government Gazette* No 20025 dated 7 May 1999 is null and void and force or effect.
  - 2.3 The applicability of Act 101 of 1965 and of Act 36 of 1947, as it pertained on 29 April 1999, continued and continues unabated as from the aforesaid date.
  - 2.4 That this order be published by way of one notice in the *Government Gazette*, and a notice in each of "the Sunday Times", "Rapport" and "City Press".
