

SOUTH AFRICAN CIVIL AVIATION AUTHORITY LEVIES ACT (ACT NO. 41 OF 1998)

NOTIFICATION OF AMENDMENT OF A DETERMINATION MADE BY THE SOUTH AFRICAN CIVIL AVIATION AUTHORITY IMPOSING A FUEL LEVY ON THE SALE OF AVIATION FUEL
