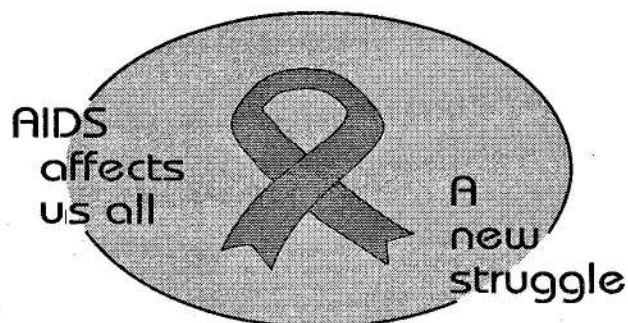

SOUTH AFRICAN CIVIL AVIATION AUTHORITY LEVIES ACT (ACT No. 41 OF 1998)
