

- (a) made the regulations set out in the Schedule hereto; and
- (b) determined that the said amendment shall come into operation on 1 October 1999.

SCHEDULE

Definitions

1. Any word or expression in these regulations to which a meaning has been assigned in the Act shall have that meaning, and—

- (a) "the Act" means the Co-operatives Act, 1981 (Act No. 91 of 1981); and
- (b) "the Regulations" means the regulations published by Government Notice No. R. 1116 of 24 April 1992, as amended by Government Notices Nos. R. 2297 of 3 December 1993, R. 1115 of 28 July 1995 and R. 1248 of 19 September 1997.
