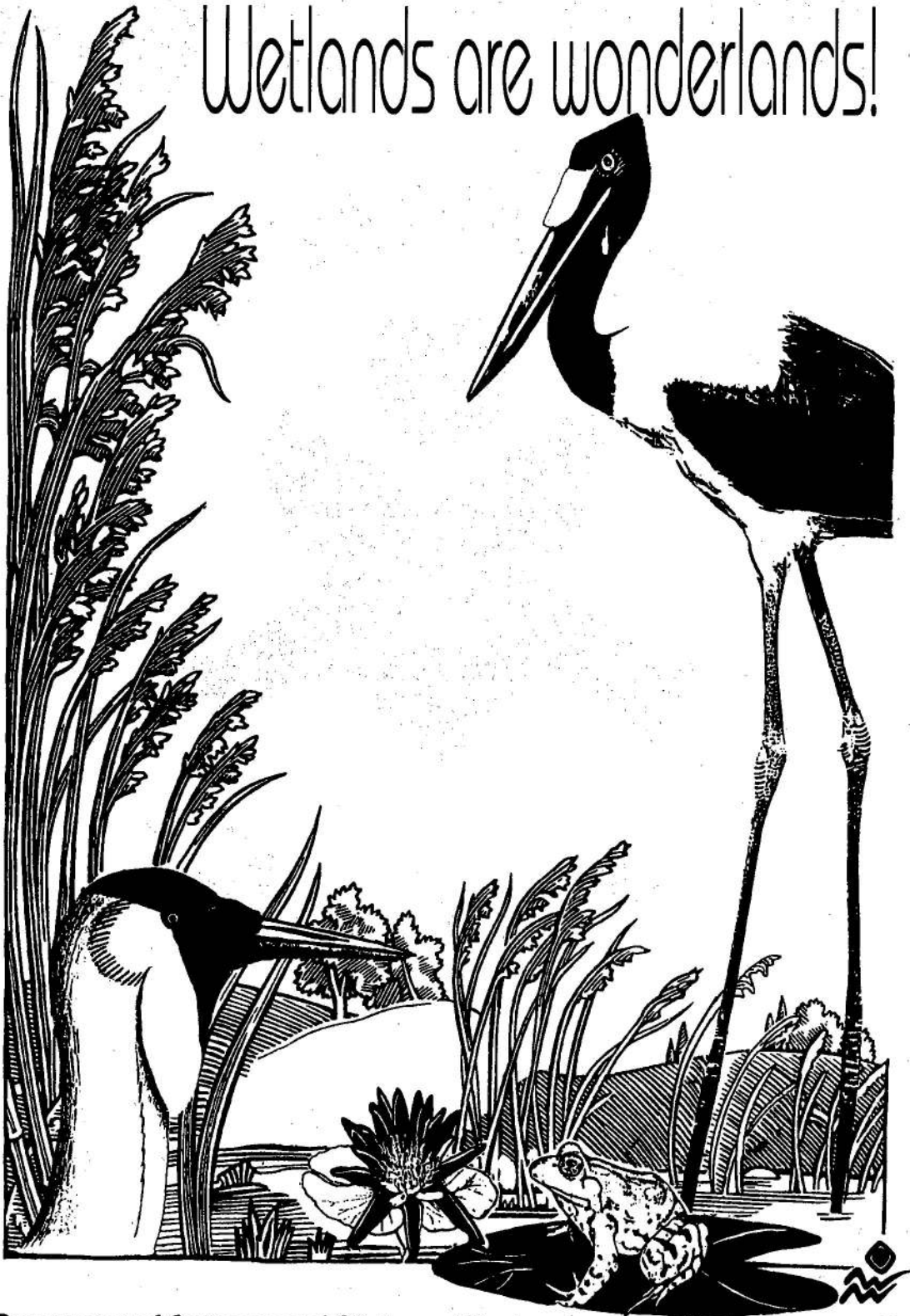
*Where is the largest amount of meteorological information in the whole of South Africa available?*
