

PLANT IMPROVEMENT ACT, 1976 (ACT No. 53 OF 1976)

SOUTH AFRICAN PLANT CERTIFICATION SCHEME FOR WINE GRAPES: AMENDMENT *

I, Angela Thokozile Didiza, Minister of Agriculture, acting under section 23 of the Plant Improvement Act, 1976 (Act No. 53 of 1976), hereby amend the South African Plant Certification Scheme for Wine Grapes published by Government Notice No. R. 2437 of 28 August 1992, as amended, to the extent set out in the Schedule.

SCHEDULE**Definition**

1. In this Schedule "the Scheme" means the South African Plant Certification Scheme for Wine Grapes published by Government Notice No. R. 2437 of 28 August 1992, as amended by Government Notices Nos. R. 3460 of 31 December 1992, R. 1084 of 25 June 1993, R. 494 of 29 March 1996 and R. 322 of 19 March 1999.

Amendment of Schedule 1 of the Scheme

2. Schedule 1 of the Scheme is hereby amended—

(a) by the substitution for paragraph 4 of the following paragraph:

"4. Mother units

A unit in which mother plants are cultivated shall comply with the following requirements:

4.1 The unit shall—

4.1.1 in the case of a greenhouse, be established in virgin soil unless the floor area of the greenhouse is covered in such a way that the roots of plants kept in containers thereon, cannot permeate to the soil on which the greenhouse is erected; and

4.1.2 otherwise be at least three hectares in extent unless the authority determines otherwise in a particular case.

4.2 The plants on the unit shall be established in virgin soil, or in soil that is free of vectors of grapevine fanleaf.

4.3 The unit shall be situated in such a way that drainage or run-off water from any other vineyard cannot run thereon.

4.4 The unit shall be isolated from any other vineyard by means of an isolation area.

4.5 Such isolation area shall—

4.5.1 in the case of a unit established in a greenhouse, be at least one metre wide; and

4.5.2 otherwise be at least three metres wide."; and

(b) by the substitution for the expression "five" where it occurs in subparagraph 5.5.1 of the expression "three".

Amendment of Schedule 3 of the Scheme

3. Schedule 3 of the Scheme is hereby amended by the substitution for subparagraph 2.1 of the following subparagraph:

"2.1 Scion graft shoots shall originate from plants that—

2.1.1 in the case of graft shoots utilised for green-grafting, may be less than two years old; and

2.1.2 otherwise are at least two years old.".

4.4 Die eenheid moet deur middel van 'n isolasiegebied van enige ander wingerd geïsoleer wees.

4.5 So 'n isolasiegebied moet—

4.5.1 in die geval van 'n eenheid wat in 'n kweekhuis gevestig is, minstens een meter wyd wees; en

4.5.2 andersins minstens drie meter wyd wees."; en

BASIC CONDITIONS OF EMPLOYMENT ACT, 1997 (ACT No. 75 OF 1997)

EMPLOYMENT CONDITIONS COMMISSION INVESTIGATION INTO THE HOSPITALITY SECTOR, SOUTH AFRICA

In terms of section 52 read with section 53 of the Basic Conditions of Employment Act, 1997, I, Membedshisi Mphumzi Shepherd Mdladlana, Minister of Labour, hereby direct the Director-General to investigate the conditions of employment and wages in the Hospitality Industry in the Republic of South Africa.

The terms of reference of the investigation shall be as follows:

To investigate conditions of employment and the rate of remuneration in respect of all classes of employees in the Hospitality Sector in the Republic of South Africa.

In the application of this terms of reference, Hospitality Sector, means any business that are associated with the following activities:

- (a) hotels and restaurants, including hotels, motels, resorts and game lodges, hostels, guest houses, guest farms and bed-&-breakfasts;
- (b) provisions of short-stay accommodation, including short-term rentals, self-catering or time shares, camps and caravan parks;
- (c) restaurants, bars canteens and other catering services, including food preparation, food and beverage services, licensed clubs and fine dining establishments; pubs and taverns; fast food outlets, snack bars and kiosks; industrial and contract caterers; function and outside caterers;
- (d) travel agencies, tour operators and related activities, including retail and general travel operations; tourism marketing and development agencies and companies; tourism authorities, commissions and boards; tourist information centers; tourism industry associations;
- (e) destination management; including tour operators and guides; venue management; museums; special attractions, management of special events, conventions, exhibitions and festivals; event, conference, festival and attraction venue management; fun fairs and parks; rafting; abseiling, hang-gliding, bungee-jump and other adventure tourism operations;
- (f) motor car rental services;

- (h) gaming and gambling, including casinos and other table, electronic and slot machine gaming outlets; clubs; gambling, betting and bookmaking operators; totalisators; lottery operations; horse racing clubs; and
- (i) inbound international airline operators.
