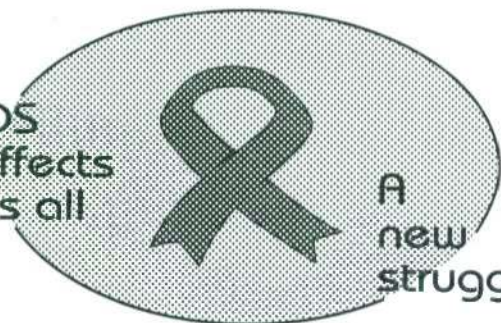

AMENDMENT OF PROVISIONAL PAYMENT (VB/83)
