

## PROCLAMATION

### TRUTH AND RECONCILIATION COMMISSION: COMMITTEE ON AMNESTY

No. R. 35, 2000

#### PROCLAMATION UNDER SECTION 20 OF THE PROMOTION OF NATIONAL UNITY AND RECONCILIATION ACT, 1995 (ACT NO. 34 OF 1995)





