

PROCLAMATION

by the

President of the Republic of South Africa

No. R. 56, 2000

DETERMINATION OF THE UPPER LIMIT OF THE SALARIES AND ALLOWANCES OF PREMIERS, MEMBERS OF EXECUTIVE COUNCILS AND MEMBERS OF PROVINCIAL LEGISLATURES

- 1 In terms of section 6(1) of the Remuneration of Public Office Bearers Act, 1998 (Act No. 20 of 1998) ("the Remuneration Act"), I hereby determine that the upper limit of the annual salaries and allowances of the various grades of office-bearers mentioned in Column 1 of the Schedule shall be as set out in Column 2, 3 or 4 of the Schedule with effect from 1 April 2000, subject to section 6(7)(a) and (b) of the Remuneration Act.
- 2 Column 4 of the Schedule applies to a re-elected member who has occupied his or her current office, or an office in the same or a higher grade according to Column 1 of the Schedule, for a continuous period of at least 24 months in total, whether before or after 2 June 1999.
- 3 Column 3 of the Schedule applies to all re-elected members other than those referred to in paragraph 2. When a re-elected member to whom Column 3 applies has held his or her current office, or an office in the same or a higher

grade according to Column 1, for a continuous period of 24 months in total, Column 4 becomes applicable to that member.

- 4 Column 2 of the Schedule applies to all members of a Provincial Legislature who are not re-elected members.
- 5 For the purposes of calculating the period of 24 months referred to in paragraphs 2 and 3, a re-elected member is regarded to have continued to be a member of a Provincial Legislature during the period 2 June 1999 until the date on which he or she was designated as such a member pursuant to the elections of that date.
- 6 In terms of section 6(4) of the Remuneration Act, I determine the amount of R40 000, 00 per annum as that portion of the remuneration of an office bearer mentioned in Column 1 of the Schedule to which section 8(1)(d) of the Income Tax Act, 1962 (Act No. 58 of 1962), applies.
- 7 Except for the salaries and allowances provided for in this Proclamation, the office-bearers mentioned in Column 1 of the Schedule are not entitled to any other remuneration, whether directly or indirectly, in respect of the offices held by them.
- 8 In this Proclamation, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Remuneration Act, the Constitution of the Republic of South Africa, 1996, or the relevant Rules and Orders contemplated in section 116 of the Constitution, bears that meaning; and

"re-elected member" means a person who –

- (a) immediately before 2 June 1999 was a member of a Provincial Legislature; and

- (b) following the election of 2 June 2000, was designated as such a member by the Electoral Commission.

9 Proclamation No.113 of 1999, published in the *Government Gazette* of 19 November 1999, is hereby repealed.

**BEPALING VAN DIE BOONSTE PERK VAN DIE SALARISSE EN TOELAES VAN
PREMIERS, LEDE VAN UITVOERENDE RADE EN LEDE VAN PROVINSIALE
WETGEWERS**

- 1 Ingevolge artikel 6(1) van die Wet op die Besoldiging van Openbare Ampsbekleërs, 1998 (Wet No. 20 van 1998) ("die Besoldigingwet"), bepaal ek hierby dat die boonste perk van die jaarlikse salarisse en toelaes van die onderskeie grade ampsbekleërs in Kolom 1 van die Bylae vermeld, met ingang van 1 April 2000 is soos in Kolom 2, 3 of 4 van die Bylae uiteengesit, behoudens artikel 6(7)(a) en (b) van die Besoldigingwet.
- 2 Kolom 4 van die Bylae is van toepassing op 'n herverkose lid wat sy/haar huidige amp of 'n amp in dieselfde of 'n hoër graad ingevolge Kolom 1 van die Bylae vir 'n totale aaneenlopende tydperk van 24 maande beklee het, hestsy voor of na 2 Junie 1999.
- 3 Kolom 3 van die Bylae is van toepassing op alle ander herverkose lede as dié wat in paragraaf 2 vermeld word. Sodra 'n herverkose lid op wie Kolom 3 van toepassing is sy/haar huidige amp of 'n amp in dieselfde of hoër graad volgens

Kolom 1 van die Bylae vir 'n totale aaneenlopende tydperk van 24 maande beklee het, is Kolom 4 op daardie lid van toepassing.

- 4 Kolom 2 van die Bylae is van toepassing op alle ander lede van 'n Proviniale Wetgewer wat nie herverkose lede is nie.
- 5 By die berekening van die tydperk van 24 maande in paragrawe 2 en 3 bedoel, word geag dat 'n herverkose lid, 'n lid van 'n Proviniale Wetgewer gebly het gedurende die tydperk 2 Junie 1999 totdat hy/sy, na aanleiding van die verkiesing van daardie datum as sodanige lid aangewys is.
- 6 Ingevolge artikel 6(4) van die Besoldigingwet, bepaal ek die bedrag van R40 000,00 per jaar as daardie gedeelte van die besoldiging van 'n ampsbekleer in Kolom 1 van die Bylae vermeld waarop artikel 8(1)(d) van die Inkomstebelastingwet, 1962 (Wet No. 58 van 1962), van toepassing is.
- 7 Behalwe vir die salarisse en toelaes waarvoor in hierdie Proklamasie voorsiening gemaak word, is die ampsbekleers in Kolom 1 van die Bylae vermeld, nie op enige ander vergoeding, direk of indirek, geregtig ten opsigte van die ampte wat hulle beklee nie.
- 8 In hierdie Proklamasie, tensy uit die samehang anders blyk, het 'n woord of uitdrukking waaraan 'n betekenis in die Besoldigingwet of die Grondwet van die Republiek van Suid-Afrika, 1996, toegeskryf is, daardie betekenis; en beteken "herverkose lid" iemand wat -
 - (a) onmiddellik voor 2 Junie 1999 'n lid van 'n Proviniale Wetgewer was; en
 - (b) na die verkiesing van 2 Junie 1999, deur die Verkiesingskommissie as sodanige lid aangestel is.

9 Proklamasie No.113 van 1999, wat in die Staatskoerant van 19 November 1999 gepubliseer is, word hierby herroep.
