DETERMINATION OF MAGISTRATES' SALARIES FOR THE PURPOSE OF THE MAGISTRATES ACT, 1993

I, Penuell Mpapa Maduna, Minister for Justice and Constitutional Development, acting under section 12(1) of the Magistrates Act, 1993 (Act No. 90 of 1993), hereby determine, as indicated in the attached Schedule, the salaries payable to magistrates with effect from 1 July 2000.

2. ANNUAL SERVICE BONUS

The service bonus of a magistrate is the service bonus, including the requirements, conditions and circumstances, which is applicable to a deputy director in the Public Service: Provided that the basis of calculation shall be on the magistrate's gross annual salary at the date on which he or she qualifies for payment.

3. MOTOR CAR FINANCING BENEFIT FOR CHIEF MAGISTRATE, REGIONAL COURT PRESIDENT AND SPECIAL GRADE CHIEF MAGISTRATE

(1) The motor car financing benefit of a chief magistrate is the motor car financing benefit, including the requirements, conditions, circumstances and basis of calculations, which is applicable to a director in the Public Service as amended from time to time.

(2) The motor car financing benefit of a regional court president and a special grade chief magistrate is the motor car financing benefit, including the requirements, conditions, circumstances and basis of calculations, which is applicable to a chief director in the Public Service as amended from time to time.

4. HOME OWNER'S ALLOWANCE

The home owner's allowance of a magistrate is the home owner's allowance, including the requirements, conditions, circumstances, and basis of calculations, which is applicable to a deputy director in the Public Service as amended from time to time.
