

MARKETING OF AGRICULTURAL PRODUCTS ACT, 1996 (ACT No. 47 OF 1996)

ESTABLISHMENT OF STATUTORY MEASURE AND DETERMINATION OF GUIDELINE PRICES: LEVY ON FRESH CITRUS FRUIT INTENDED FOR EXPORT

I, Angela Thokozile Didiza, Minister of Agriculture, acting under sections 13 and 15 of the Marketing of Agricultural Products Act, 1996 (Act No. 47 of 1996), hereby –

- (a) establish the statutory measure set out in the Schedule; and
- (b) determine that the guideline price for export citrus fruit shall be R1,50 per kg.

SCHEDULE

Definitions

1. In this Schedule any word or expression to which a meaning has been assigned in the Act shall have that meaning, and unless the context otherwise indicates –

“CGA” means the Citrus Growers Association of South Africa, incorporated under section 21 of the Companies Act, 1973 (Act No. 61 of 1973) with registration number 2000/010147/08;

“exporter” means an exporter of citrus fruit;

“export citrus fruit” means fresh citrus fruit intended for export;

“producer” means a grower of export citrus fruit; and

“the Act” means the Marketing of Agricultural Products Act, 1996 (Act No. 47 of 1996).

Purpose and aims of statutory measure and the relation thereof to the objectives of the Act

2. The purpose and aims of this statutory measure is to compel the parties to pay a levy to the CGA. The levy is needed by CGA to gain and maintain market access, to fund and control research and development, to set fruit quality standards and to ensure effective communication. Market access will be increased for all participants through the conducting of research into new markets and to maintain existing markets. This will enhance the choice of producers to market products in markets of their choice and to optimise export earnings. As earnings are the highest in the most discerning markets, it is necessary that fruit standards are maintained and that technical barriers on a phytosanitary and sanitary level are overcome.

The measure will not be detrimental to the number of employment opportunities or fair labour practice to all role players in the citrus industry. The statutory measure aims to maintain the position of South Africa as the third largest producer of fresh citrus in the world.

The measure will be administered by CGA.

Product to which statutory measure applies

3. This statutory measure shall apply to all export citrus fruit.

Area in which statutory measure shall apply

4. This statutory measure shall apply in the geographical area of the Republic of South Africa.

Imposition of levy

5. A levy is hereby imposed on export citrus fruit.

Amount of levy

6. The levy shall amount to R0,014c per kilogram for export citrus fruit.

Persons by whom and to whom levy is payable

7. The levy imposed in terms of clause 5 shall –

(a) be payable by producers of export citrus fruit; and

(b) be payable in the manner set out in clause 8.

Payment of levy

8. (1) Payment of the levy shall be made by the Perishable Product Export Control Board, or by the exporter of the export citrus fruit concerned: Provided that –

- (a) the amount of the levy may be recovered from the producer of that export citrus fruit; and
- (b) a collection fee 1% of the levy (1% of 1.4c/Kg) may be deducted from the levy collected.

(2) Payment shall be made no later than thirty days after the fruit has been approved for export in terms of the Agricultural Product Standards Act by means of a cheque or electronic transfer in favour of CGA, and shall –

Dit sal produsente die geleentheid bied om produkte te bemark in markte van hul eie keuse, en om uitvoer verdienste te optimaliseer. By combining compulsory registration with the keeping of information and the rendering of returns on an individual basis, information for the whole of the industry can be co-ordinated to ensure the orderly collection of levies.

The measure will not be detrimental to the number of employment opportunities or fair labour practice and only affect the role-players involved.

It will be administered by the Citrus Growers Association.

Product to which statutory measure applies

3. This statutory measure shall apply to all export citrus fruit.

Area in which statutory measure shall apply

4. This statutory measure shall apply in the geographical area of the Republic of South Africa.

Registration of parties concerned

5. All exporters and all producers shall register with the CGA.

Application for registration

6. Application for registration shall –

- (a) be made within 30 days of the commencement of this statutory measure, and in the case of a person becoming a party as contemplated in clause 5 after such date of commencement, within 30 days of becoming such a party;
- (b) be made on the application form obtainable free of charge from CGA.



Product to which statutory measure applies

3. This statutory measure shall apply to all export citrus fruit.

Area in which statutory measure shall apply

4. This statutory measure shall apply in the geographical area of the Republic of South Africa.

Records to be kept and returns to be rendered

5. (1) All exporters and all producers shall keep such records and render the returns as may be required by the CGA relating to export citrus fruit produced, received, sold, exported or otherwise utilised.

(2) The Perishable Product Export Control Board shall render a copy of all inspection certificates or the information required by the CGA contained in such certificates within the period specified in subclause (4) to the CGA.

(3) The records referred to in subclause (1) shall –

(a) be recorded on a computer or with ink in a book; and

(b) be kept at the registered premises of the person required to keep it for a period of at least three years.

(4) The returns referred to in subclauses (1) and (2) shall be rendered on a form obtainable free of charge for this purpose from the CGA, within thirty (30) days after the end of each calendar month and shall –

Definition

1. In this Schedule "the regulations" means the regulations published by Government Notice No. R. 1048 of 25 May 1984, as amended by Government Notice No. R. 2687 of 6 December 1985.

Amendment of regulation 1 of the regulations

2. Regulation 1 of the regulations is hereby amended –

(a) by inserting the following definitions before the definition of "excessive soil loss":

"biological control" means the use of natural enemies of category 1, 2 and 3 plants to control such plants;

"biological control agent" means a natural enemy of category 1, 2 or 3 plants that is used to control such plants;

"biological control expert" means an academic or research institute or an academic or research organisation established by legislation which, or a person associated with or in the employment of such an institute or organisation who, practises and researches biological control of category 1, 2 and 3 plants;

"biological control reserve" means an area designated by the executive officer in terms of regulation 15D of the regulations for the breeding of biological control agents;

"bush encroachment" means stands of plants of the kinds specified in column 1 of Table 4 where individual plants are closer to each other than three times the mean crown diameter;

'category 1 plants' means plants of the kinds specified as category 1 in column 3 of Table 3 opposite the names of the respective kinds of plants;

'category 2 plants' means plants of the kinds specified as category 2 in column 3 of Table 3 opposite the names of the respective kinds of plants;

'category 3 plants' means plants of the kinds specified as category 3 in column 3 of Table 3 opposite the names of the respective kinds of plants;

'control' means to combat category 1, 2 and 3 plants by means of the methods prescribed in regulation 15E to the extent necessary to prevent or to contain the occurrence, establishment, growth, multiplication, propagation, regeneration and spreading of such plants;

'demarcated area' means an area of land approved by the executive officer in terms of regulation 15B of the regulations for the occurrence, establishment and maintenance of category 2 plants;

'environment conservation regulations' means regulations in terms of the Environment Conservation Act, 1989 (Act No. 73 of 1989), as published by Government Notice No. R.1182 of 5 September 1997, as amended from time to time, or similar regulations promulgated under legislation administered by the Department of Environmental Affairs and Tourism;"

(b) by inserting the following definition after the definition of "flood area":

" 'propagating material' means any material of a plant that can be used for the propagation of that plant;"

(c) by inserting the following definition after the definition of "secretary":

" 'sell' includes agree to sell, or offer, advertise, keep, exhibit, send, consign, convey or deliver for sale, or exchange for anything or dispose of or deliver to any other person in any manner, whether for a consideration or otherwise; and 'sold' and 'sale' have corresponding meanings;"

(d) by deleting the word "and" after the definition of "veld";

(e) by adding the word "and" after the definition of "waterway"; and

(f) by adding the following definition:

"wetland" means land which is transitional between terrestrial and aquatic systems where the water table is usually at or near the surface, or the land is periodically covered with shallow water, and which land in normal circumstances supports or would support vegetation typically adapted to life in saturated soil."

Substitution of regulation 15 of the regulations

3. Regulation 15 of the regulations is hereby substituted for the following regulation:

"Declaration of weeds and invader plants"

15. (1) Plants of the kinds specified in column 1 of Table 3 as category 1 plants are hereby declared weeds to the extent indicated in column 3 of the said Table opposite the names of the respective kinds of plants.

(2) Plants of the kinds specified in column 1 of Table 3 as category 2 plants and as category 3 plants are hereby declared invader plants to the extent indicated in column 3 of the said Table opposite the names of the respective kinds of plants."

Insertion of regulations 15A to 15F

4. The regulations are hereby amended by the insertion of the following regulations after regulation 15:

"Combating of category 1 plants"

15A.(1) Category 1 plants may not occur on any land or inland water surface other than in biological control reserves.

(2) A land user shall control any category 1 plants that occur on any land or inland water surface in contravention of the provisions of sub-regulation (1) by means of the methods prescribed in regulation 15E.

(3) No person shall, except in or for purposes of a biological control reserve –

(a) establish, plant, maintain, multiply or propagate category 1 plants;

(b) import or sell propagating material of category 1 plants or any category 1 plants;

(c) acquire propagating material of category 1 plants or any category 1 plants.

(4) The executive officer may, on good cause shown in writing by the land user, grant written exemption from compliance with the requirements of sub-regulation (1) on such conditions as the executive officer may determine in each case.

Combating of category 2 plants

15B. (1) Category 2 plants may not occur on any land or inland water surface other than a demarcated area or a biological control reserve.

(2) (a) The executive officer may on application in writing demarcate an area as an area where category 2 plants may occur, be established and be maintained.

(b) An area in respect of which a water use license for stream flow reduction activities has been issued in terms of section 36 of the National Water Act, 1998 (Act No. 36 of 1998) shall be deemed to be a demarcated area.

(3) The executive officer shall demarcate an area for the occurrence, establishment and maintenance of category 2 plants only if –

- (a) the category 2 plants in the area are cultivated under controlled circumstances; and
- (b) the land user concerned has been authorised to use water in terms of the National Water Act, 1998 (Act No. 36 of 1998); and
- (c) the category 2 plants or products of category 2 plants in the area are demonstrated to primarily serve a commercial purpose, use as a woodlot, shelter belt, building material, animal fodder, soil stabilisation, medicinal or other beneficial function that the executive officer may approve; and
- (d) all reasonable steps are taken to curtail the spreading of propagating material of the category 2 plants outside the demarcated areas.

(4) When an area is demarcated for the occurrence, establishment and maintenance of category 2 plants the executive officer may impose such additional conditions as may reasonably be deemed necessary to keep the category 2 plants in the area in check.

(5) No person shall sell propagating material of category 2 plants or any category 2 plants to another person unless such other person is a land user of a demarcated area or of a biological control reserve.

(6) No person shall acquire propagating material of category 2 plants or any category 2 plants unless such material or such plants are intended for use in a demarcated area or in a biological control reserve.

(7) Propagating material of category 2 plants or category 2 plants shall only be imported or sold in accordance with the provisions of the Plant Improvement Act, 1976 (Act No. 53 of 1976), the Agricultural Pests Act, 1983 (Act No. 36 of 1983) and the environment conservation regulations.

(8) A land user shall control any category 2 plants that occur on any land or inland water surface in contravention of the provisions of sub-regulation (1) by means of the methods prescribed in regulation 15E.

(9) Unless authorised thereto in terms of the National Water Act, 1998 (Act No. 36 of 1998), no land user shall allow category 2 plants to occur within 30 meters of the 1:50 year flood line of a river, stream, spring, natural channel in which water flows regularly or intermittently, lake, dam or wetland.

(10) The executive officer may, on good cause shown in writing by the land user, grant written exemption from compliance with one or more of the requirements of sub-regulations (1), (3), (5), (6), (8) and (9) on such conditions as the executive officer may determine in each case.

Combating of category 3 plants

15C. (1) Category 3 plants shall not occur on any land or inland water surface other than in a biological control reserve.

(2) Subject to the provisions of sub-regulation (3), the provisions of sub-regulation (1) shall not apply in respect of category 3 plants already in existence at the time of the commencement of these regulations.

(3) (a) No land user shall allow category 3 plants to occur within 30 meters of the 1:50 year flood line of a river, stream, spring, natural channel in which water flows regularly or intermittently, lake, dam or wetland.

(b) The executive officer may impose such additional conditions as may reasonably be deemed necessary with regard to category 3 plants already in existence at the time of the commencement of these regulations.

(c) A land user must take all reasonable steps to curtail the spreading of propagating material of category 3 plants.

(d) The executive officer may, after consultation with the land user, issue a direction in terms of section 7 of the Act that category 3 plants in existence at the time of the commencement of these regulations must be controlled by means of the measures prescribed in regulation 15F.

(4) No person shall, except in or for purposes of a biological control reserve –

- (a) plant, establish, maintain, multiply or propagate category 3 plants;
- (b) import or sell propagating material of category 3 plants or any category 3 plants;
- (c) acquire propagating material of category 3 plants or any category 3 plants.

(5) The executive officer may, on good cause shown in writing by the land user, grant written exemption from compliance with one or more of the requirements of sub-regulations (1), (3) and (4) on such conditions as the executive officer may determine in each case.

Designation of biological control reserves

15D. (1) The executive officer may on application in writing designate an area as a biological control reserve.

(2) The executive officer shall designate an area as a biological control reserve only if –

- (a) the area concerned is used for the breeding of biological control agents by a biological control expert; and
- (b) no other measures that may destroy or render the biological control ineffective are applied in that area; and
- (c) the area concerned serves as a refuge from where biological control agents can move or be distributed to other infestations of category 1, 2 and 3 plants.

Methods of control

15E. (1) Where category 1, 2 or 3 plants occur contrary to the provisions of these regulations, a land user shall control such plants by means of one or more of the following methods of control as is appropriate for the species concerned and the ecosystem in which it occurs:

- (a) Uprooting, felling, cutting or burning;

- (b) Treatment with a weed killer that is registered for use in connection with such plants in accordance with the directions for the use of such a weed killer;
- (c) Biological control carried out in accordance with the stipulations of the Agricultural Pests Act, 1983 (Act No. 36 of 1983), the Environment Conservation Act, 1989 (Act No. 73 of 1989) and any other applicable legislation;
- (d) Any other method of treatment recognised by the executive officer that has as its object the control of the plants concerned, subject to the provisions of sub-regulation (4);
- (e) A combination of one or more of the methods prescribed in paragraphs (a), (b), (c), and (d), save that biological control reserves and areas where biological control agents are effective shall not be disturbed by other control methods to the extent that the agents are destroyed or become ineffective.

(2) The methods contemplated in sub-regulation (1) shall also be applied with regard to the propagating material and the re-growth of category 1, 2 and 3 plants in order to prevent such plants from forming seed or re-establishing in any manner.

(3) The performance of an act of control is not in itself proof that the objects of the control methods have been achieved and follow-up operations are mandatory to achieve the appropriate level of combating.

(4) Where uncertainty exists about the presence or efficacy of any biological control agent, a biological control expert shall be consulted.

(5) Any action taken to control category 1, 2 and 3 plants shall be executed with caution and in a manner that will cause the least possible damage to the environment.

Application of other laws

15F. Nothing contained in this regulation shall derogate in any way from any obligation imposed on any land user in terms of any other law.”

Substitution of Regulation 16 of the regulations

5. Regulation 16 of the regulations is hereby substituted for the following regulation:

"Indicators of bush encroachment"

16. (1) Indigenous plants of the kinds specified in column 1 of Table 4 are regarded as indicator plants indicating bush encroachment in the areas specified in column 2 of the said Table opposite the names of the respective kinds of plants.

(2) A land user of an area in which natural vegetation occurs and that contains communities of indicator plants shall follow practices to prevent the deterioration of natural resources and to combat bush encroachment where it occurs.

(3) One or more of the following practices shall be followed with regard to communities of indicator plants contemplated in sub-regulation (2) in order to remove the cause of the deterioration of the natural resources and to improve and maintain the production potential of the natural pastoral land:

- (a) Uprooting, felling or cutting;
- (b) Treatment with a weed killer that is registered for use in connection with such plants in accordance with the directions for the use of such a weed killer;
- (c) The application of control measures regarding the utilisation and protection of veld in terms of regulation 9;
- (d) The application of control measures regarding livestock reduction or removal of animals in terms of regulations 10 and 11;
- (e) Any other method or strategy that may be applicable and that is specified by the executive officer by means of a directive.”.

Substitution of Tables 3 and 4 of the regulations

6. The following tables are hereby substituted for Tables 3 and 4 of the regulations, respectively:

BYLAE**Woordomskrywing**

1. In hierdie Bylae beteken "die regulasies" die regulasies gepubliseer by Goewermentskennisgewing No. R. 1048 van 25 Mei 1984, soos gewysig deur Goewermentskennisgewing No. R. 2687 van 6 Desember 1985.

Wysiging van regulasie 1 van die regulasies

2. Regulasie 1 van die regulasies word hierby gewysig –

(a) deur die invoeging voor die omskrywing van "afleibaan" van die volgende omskrywing:

"afgebakte gebied" 'n gebied ingevolge regulasie 15B van die regulasies deur die uitvoerende beampete goedgekeur vir die voorkoms, vestiging en instandhouding van kategorie 2 plante;"

(b) deur die invoeging na die omskrywing van "afloopwater" van die volgende omskrywings:

"beheer" om kategorie 1, 2 en 3 plante te bestry by wyse van die metodes in regulasie 15E voorgeskryf tot die mate nodig om die voorkoms, vestiging, groei, vermeerdering, voortplanting, regenerasie en verspreiding van sodanige plante te voorkom of in toom te hou;

"biologiese beheer" die gebruik van natuurlike vyande van kategorie 1, 2 en 3 plante om sodanige plante te beheer;

"biologiese beheeragent" 'n natuurlike vyand van kategorie 1, 2 of 3 plante wat gebruik word om sodanige plante te beheer;

'biologiese beheer' deskundige van 'n akademiese of navorsingsinstituut of 'n akademiese of navorsingsorganisasie deur wetgewing ingestel, of 'n persoon verbonde aan of in diens van sodanige instituut of organisasie wat biologiese beheer van kategorie 1, 2 en 3 plante toepas en navors;

'biologiese beheer reservaat' 'n gebied ingevolge regulasie 15D van die regulasies deur die uitvoerende beampte aangewys vir die teel van biologiese beheeragente;

'bosindringing' lappe plante van die soorte in kolom 1 van Tabel 4 vermeld waar individuele plante nader aan mekaar as drie maal die gemiddelde deursnee van die kroon is;";

(c) deur die invoeging na die omskrywing van "helling" van die volgende omskrywings:

"'kategorie 1 plante' plante van die soorte vermeld as kategorie 1 in kolom 3 van Tabel 3 teenoor die name van die onderskeie soorte plante;

"'kategorie 2 plante' plante van die soorte vermeld as kategorie 2 in kolom 3 van Tabel 3 teenoor die name van die onderskeie soorte plante;

"'kategorie 3 plante' plante van die soorte vermeld as kategorie 3 in kolom 3 van Tabel 3 teenoor die name van die onderskeie soorte plante;

'omgewingsbewaringsregulasies' regulasies ingevolge die Wet op Omgewingsbewaring, 1989 (Wet No. 73 van 1989), soos gepubliseer by Goewermentskennisgewing No. R. 1182 van 5 September 1997, soos van tyd tot tyd gewysig, of soortgelyke regulasies gepromulgeer kragtens wetgewing geadministreer deur die Departement van Omgewingsake en Toerisme;";

(d) deur die invoeging na die omskrywing van "veld" van die volgende omskrywings:

"'verkoop' ook ooreenkom om te verkoop, vir verkoop aanbied, adverteer, hou, uitstal, versend, stuur, vervoer of lewer vir verkoop, of op enige wyse, hetsy teen 'n teenprestasie of andersins, aan iemand uitruil, van die hand sit of lewer, en het 'verkoop', wanneer dit as 'n naawoord gebruik word, 'n ooreenstemmende betekenis;

'vleiland' grond wat oorganklik is tussen aard- en watersisteme waar die watertafel gewoonlik by of naby die bogrond is, of waar die grond periodiek met vlak water bedek is, en welke grond onder normale omstandighede plantegroei, wat tipies tot lewe in deurdrenkte grond aangepas het, ondersteun of kan ondersteun;";

(e) deur die woord "en" na die omskrywing van "voorligtingskantoor" by te voeg; en

(f) deur die byvoeging van die volgende omskrywing:

"voortplantingsmateriaal" enige materiaal van 'n plant wat vir die voortplanting van daardie plant gebruik kan word."

Vervanging van regulasie 15 van die regulasies

3. Regulasie 15 van die regulasies word hierby deur die volgende regulasie vervang:

"Verklaring van onkruide en indringerplante"

15. (1) Plante van die soorte vermeld in kolom 1 van Tabel 3 as kategorie 1 plante word hierby as onkruide verklaar tot die mate in kolom 3 van die betrokke Tabel teenoor die name van die onderskeie soorte plante aangedui.

(2) Plante van die soorte vermeld in kolom 1 van Tabel 3 as kategorie 2 plante en as kategorie 3 plante word hierby as indringerplante verklaar tot die mate in kolom 3 van die betrokke Tabel teenoor die name van die onderskeie soorte plante aangedui."

Invoeging van regulasies 15A tot 15F

4. Die regulasies word hierby gewysig deur die invoeging van die volgende regulasies na regulasie 15:

"Bestryding van kategorie 1 plante"

15A. (1) Kategorie 1 plante mag nie op enige grond of binnelandse wateroppervlakte behalwe in biologiese beheer reservete voorkom nie.

(2) 'n Grondgebruiker moet enige kategorie 1 plante watstrydig met die bepalings van subregulasie 1 op enige grond of binnelandse wateroppervlakte voorkom, by wyse van die maatreëls in regulasie 15E voorgeskryf, beheer.

(3) Niemand mag, behalwe in of vir doeleindes van 'n biologiese beheer reservaat –

- (a) kategorie 1 plante plant, vestig, in stand hou, vermeerder of laat voortplant nie;
- (b) voortplantingsmateriaal van kategorie 1 plante of enige kategorie 1 plante invoer of verkoop nie; en
- (c) voortplantingsmateriaal van kategorie 1 plante of enige kategorie 1 plante verkry nie.

(4) Die uitvoerende beampte kan, indien goeie gronde skriftelik deur die grondgebruiker aangevoer word, skriftelik vrystelling verleen van die nakoming van die vereistes van subregulasie (1) op sodanige voorwaardes as wat die uitvoerende beampte in elke geval mag bepaal.

Bestryding van kategorie 2 plante

15B. (1) Kategorie 2 plante mag nie op enige grond of binnelandse wateroppervlakte behalwe in 'n afgebakende gebied of 'n biologiese beheer reservaat voorkom nie.

(2) (a) Die uitvoerende beampte kan op skriftelike aansoek 'n gebied afbaken as 'n gebied waar kategorie 2 plante mag voorkom, gevestig en in stand gehou kan word.

(b) 'n Gebied ten opsigte waarvan 'n watergebruik lisensie vir stroomvloeiverminderingbedrywighede uitgereik is ingevolge artikel 36 van die Nasionale Waterwet, 1998 (Wet No. 36 van 1998) word geag 'n afgebakende gebied te wees.

(3) Die uitvoerende beampte baken 'n gebied af vir die voorkoms, vestiging en instandhouding van kategorie 2 plante alleenlik indien –

(a) die kategorie 2 plante in die gebied onder beheerde omstandighede verbou word; en

(b) die betrokke grondgebruiker gemagtig is om water te gebruik ingevolge die Nasionale Waterwet, 1998 (Wet No. 36 van 1998); en

(c) die kategorie 2 plante of produkte van kategorie 2 plante in die gebied aangetoon word om hoofsaaklik 'n kommersiële doel te dien, gebruik as 'n brandhoutbospersel, windbreek, boumateriaal, voer vir diere, grondstabilisasie, medisinale of ander voordelelike funksie wat die uitvoerende beampte mag goedkeur; en

(d) alle redelike stappe geneem word om die verspreiding van voortplantingsmateriaal van die kategorie 2 plante buite die afgebakende gebiede te beperk.

(4) Wanneer 'n gebied afbaken word vir die voorkoms, vestiging en instandhouding van kategorie 2 plante kan die uitvoerende beampte sodanige addisionele voorwaardes ople as wat rederlikerwyse nodig geag mag word om die kategorie 2 plante in die gebied in bedwang te hou.

(5) Niemand mag voortplantingsmateriaal van kategorie 2 plante of enige kategorie 2 plante aan 'n ander persoon verkoop nie tensy sodanige ander persoon 'n grondgebruiker is van 'n afgebakende gebied of van 'n biologiese beheer reservaat.

(6) Niemand mag voortplantingsmateriaal van kategorie 2 plante of enige kategorie 2 plante verkry nie tensy sodanige materiaal of sodanige plante bedoel is vir gebruik in 'n afgebakende gebied of in 'n biologiese beheer reservaat.

(7) Voortplantingsmateriaal van kategorie 2 plante of kategorie 2 plante word alleenlik ingevoer of verkoop ooreenkomsdig die bepalings van die Wet op Plantverbetering, 1976 (Wet No. 53 van 1976), die Wet op Landbouplae, 1983 (Wet No. 36 van 1983) en die omgewingsbewaringsregulasies.

(8) 'n Grondgebruiker moet enige kategorie 2 plante wat strydig met die bepalings van subregulasie 1 op enige grond of binnelandse wateroppervlakte voorkom, by wyse van die maatreëls in regulasie 15E voorgeskryf, beheer.

(9) Tensy daartoe gemagtig ingevolge die Nasionale Waterwet, 1998 (Wet No. 36 van 1998), mag geen grondgebruiker kategorie 2 plante toelaat om binne 30 meter vanaf die 1:50 jaar vloedlyn van 'n rivier, stroom, bron, natuurlike kanaal waarin water gereeld of wisselvallig vloei, meer, dam of vleiland voor te kom nie.

(10) Die uitvoerende beampte kan, indien goeie gronde skriftelik deur die grondgebruiker aangevoer word, skriftelik vrysteling verleen van een of meer van die vereistes van subregulasies (1), (3), (5), (6), (8) en (9) op sodanige voorwaardes as wat die uitvoerende beampte in elke geval mag bepaal.

Bestryding van kategorie 3 plante

15C. (1) Kategorie 3 plante mag nie op enige grond of binnelandse wateroppervlakte behalwe in biologiese beheer reservate voorkom nie.

(2) Onderhewig aan die bepalings van subregulasie (3), is die bepalings van subregulasie (1) nie van toepassing nie ten opsigte van kategorie 3 plante wat reeds bestaan ten tyde van die inwerkingtreding van hierdie regulasies.

(3) (a) Geen grondgebruiker mag kategorie 3 plante toelaat om binne 30 meter vanaf die 1:50 jaar vloedlyn van 'n rivier, stroom, bron, natuurlike kanaal waarin water gereeld of wisselvallig vloei, meer, dam of vleiland voor te kom nie.

(b) Die uitvoerende beampte kan sodanige addisionele voorwaardes ople as wat redelikerwyse nodig geag mag word met betrekking tot kategorie 3 plante wat reeds bestaan ten tyde van die inwerkingtreding van hierdie regulasies.

(c) 'n Grondgebruiker moet alle redelike stappe neem om die verspreiding van voortplantingsmateriaal van kategorie 3 plante te beperk.

(d) Die uitvoerende beampte kan, na oorleg met die grondgebruiker, 'n lasgewing ingevolge artikel 7 van die Wet uitreik dat kategorie 3 plante wat reeds bestaan ten tyde van die inwerkingtreding van hierdie regulasies, beheer moet word by wyse van die maatreëls in regulasie 15E voorgeskryf.

(4) Niemand mag, behalwe in of vir doeleindes van 'n biologiese beheer reservaat –

(a) kategorie 3 plante plant, vestig, in stand hou, vermeerder of laat voortplant nie;

(b) voortplantingsmateriaal van kategorie 3 plante of enige kategorie 3 plante invoer of verkoop nie; en

(c) voortplantingsmateriaal van kategorie 3 plante of enige kategorie 3 plante verkry nie.

(5) Die uitvoerende beampte kan, indien goeie gronde skriftelik deur die grondgebruiker aangevoer word, skriftelik vrysteling verleen van een of meer van die vereistes van subregulasies (1), (3) en (4) op sodanige voorwaardes as wat die uitvoerende beampte in elke geval mag bepaal.

Aanwysing van biologiese beheer reserve

15D. (1) Die uitvoerende beampte kan op skriftelike aansoek 'n gebied as 'n biologiese beheer reservaat aanwys.

(2) Die uitvoerende beampte wys 'n area aan as 'n biologiese beheer reservaat alleenlik indien –

(a) die betrokke area gebruik word vir die teel van biologiese beheeragtige deur 'n biologiese beheer deskundige; en

(b) geen ander maatreëls wat die biologiese beheer vernietig of ondoeltreffend kan maak in daardie gebied toegepas word nie; en

(c) die betrokke gebied dien as 'n toevlugsoord waarvandaan biologiese beheeragtige kan beweeg of versprei kan word na ander besmettings van kategorie 1, 2 of 3 plante.

Beheermetodes

15E. (1) Waar kategorie 1, 2 of 3 plante strydig met die bepalings van hierdie regulasies voorkom, moet 'n grondgebruiker sodanige plante beheer by wyse van een of meer van die volgende beheermetodes soos wat gepas is vir die betrokke spesie en die ekosisteem waarin dit voorkom:

(a) Ontworteling, afkapping, afsnyding of verbranding;

- (d) Enige ander metode van behandeling deur die uitvoerende beampte erken wat die beheer van die betrokke plante as oogmerk het, onderhewig aan die bepalings van subregulasie (4);
- (e) 'n Kombinasie van een of meer van die metodes voorgeskryf in paragrawe (a), (b), (c) en (d), behalwe dat biologiese beheer reserve en gebiede waar biologiese beheeragtige effekief is, nie deur ander beheermaatreëls versteur word tot die mate dat die agente vernietig word of ondoeltreffend word nie.

(2) Die metodes in subregulasie 1. beoog, moet ook toegepas word met betrekking tot die voortplantingsmateriaal en die hergroei van kategorie 1, 2 en 3 plante ten einde sodanige plante te verhoed om saad te vorm of om op enige wyse te hervestig.

(3) Die verrigting van 'n daad van beheer is nie op sigself bewys dat die oogmerk van die beheermetodes bereik is nie en opvolghandelinge is verpligtend om die gepaste vlak van bestryding te behaal.

(4) Waar daar onsekerheid heers oor die teenwoordigheid of doeltreffendheid van 'n biologiese beheeragent, moet 'n biologiese beheer deskundige geraadpleeg word.

(5) Enige stappe gedoen om kategorie 1, 2 en 3 plante te beheer, moet omsigtig gedoen word en op 'n wyse wat die minste moontlike skade aan die omgewing sal aanrig.

16. (1) Inheemse plante van die soorte vermeld in kolom 1 van Tabel 4 word beskou as indikatorplante wat bosindringing aandui in die gebiede vermeld in kolom 2 van die genoemde Tabel teenoor die name van die onderskeie soorte plante.

(2) 'n Grondgebruiker van 'n gebied waarin natuurlike plantegroei voorkom en wat lappe indikatorplante bevat, moet praktyke volg om die agteruitgang van natuurlike hulpbronne te voorkom en om bosindringing te bestry waar dit voorkom.

(3) Een of meer van die volgende praktyke moet gevolg word met betrekking tot lappe indikatorplante in subregulasie (2) beoog ten einde die oorsaak van die agteruitgang van die natuurlike hulpbronne te verwijder en om die produksiepotensiaal van die natuurlike landelike grond te verbeter en in stand te hou:

- (a) Ontworteling, afkapping of afsnyding;
- (b) Behandeling met 'n onkruiddoder wat geregistreer is vir gebruik in verband met sodanige plante ooreenkomsdig die voorskrifte vir die gebruik van sodanige onkruiddoder;
- (c) Die toepassing van beheermaatreëls betreffende die gebruik en beskerming van veld ingevolge regulasie 9;
- (d) Die toepassing van beheermaatreëls betreffende vermindering van vee of verwijdering van diere ingevolge regulasies 10 en 11;
- (e) Enige ander metode of strategie wat toepaslik kan wees en wat deur die uitvoerende beampte aangedui word by wyse van 'n lasgewing."




