CORRECTION NOTICE

NATIONAL BARGAINING COUNCIL OF THE LEATHER INDUSTRY OF SOUTH AFRICA: EXTENSION OF GENERAL GOODS AND HANDBAG SECTION COLLECTIVE RE-ENACTING AND AMENDING AGREEMENT TO NON-PARTIES

The following corrections to Government Notice No. R. 46 appearing in *Government Gazette* No. 20823 of 28 January 2000, are hereby published for general information:

1. In the English text to the Schedule:

1.1 "6. CLAUSE 4: WAGES, RATES AND RENUMERATION"

- (1) Renumber the existing subclause (13) to read (14).
- (2) Insert the following new subclause (13):

"(13) ***Paid time for trade union meetings***

Employees who are members of the trade unions will be entitled to one hour's paid leave on a quarterly basis to meet with trade union officials, provided that such meeting is conducted during the last hour of a working day, as arranged with the employer."

1.2 "8. CLAUSE 26:"

Substitute clause 8 for the following:

"8. CLAUSE 27:"

- (1) Insert the new clause 27 after the renumbered clause 26 [as per clause 8 (2) of Government Notice No. R. 288 of 12 March 1999]:

"27. **LIMITED DURATION EMPLOYMENT CONTRACT**

In the event of an employer engaging an employee for a limited duration, a form as set out in Annexure E must be completed, witnessed by a shop steward where possible, and a copy made available to the worker and relevant shop steward."
