SOUTH AFRICAN NURSING COUNCIL

REGULATIONS RELATING TO EXAMINATION FEES OF THE SOUTH AFRICAN NURSING COUNCIL

The Minister of Health has, in terms of section 45(1) of the Nursing Act, 1978 (Act No. 50 of 1978), in consultation with the South African Nursing Council, made the regulations in the Schedule.

SCHEDULE

1. In these regulations "the Regulations" means regulations published under Government Notice No. R. 7 of 8 January 1993 as amended by Government Notices R. 2174 of 19 November 1993 and R. 16 of 3 January 1997; repeated in R. 60 of 17 January 1997.

Amendment of regulation 16 of the regulations

2. Regulation 16 of the regulations is hereby amended by the—

- (a) substitution in paragraph (a) for the expression "R45,00 plus VAT" of the expression "R60,00 plus VAT"; and
- (b) substitution in paragraph (b) for the expression "55,00 plus VAT" of the expression "R70,00 plus VAT".

3. These regulations come into operation on the date of publication.

Die Minister van Gesondheid het, in ooreenstemming met die Suid-Afrikaanse Raad op Verpleging kragtens Artikel 45(1) van die Wet op Verpleging (Wet Nr 50 van 1978) die regulasies in die Bylae uitgevaardig.

BYLAE

1. In hierdie regulasies beteken "die Regulasies" die regulasies afgekondig in Goewermenskennisgewing R. 7 van 8 Januarie 1993 soos gewysig deur Goewermenskennisgewing R. 2174 van 19 November 1993 en R. 16 van 3 Januarie 1997, herhaal in R. 60 van 17 Januarie 1997.

Wysiging van regulasie 16 van die Regulasies

2. Regulasie 16 van die regulasies word hierdeur gewysig deur—

- (a) die uitdrukking "R45,00 plus BTW" in paragraaf (a) met die uitdrukking "R60,00 plus BTW" te vervang; en
- (b) die uitdrukking "R55,00 plus BTW" in paragraaf (b) met die uitdrukking "R70,00 plus BTW" te vervang.

3. Hierdie regulasies tree op datum van publikasie in werking.
