PROCLAMATION
by the
President of the Republic of South Africa

No. R. 118, 2001

SPECIAL INVESTIGATING UNITS AND SPECIAL TRIBUNALS ACT, 1996
(ACT NO. 74 OF 1996)

1. Proclamation No. R. 24 of 14 March 1997, as amended by Proclamation No. R. 72 of 11 November 1997 and Proclamation No. R. 42 of 28 April 1998, is hereby repealed.
2. Under section 2(1)(a) of the Special Investigating Units and Special Tribunals Act, 1996 (Act No. 74 of 1996), I hereby establish a Special Investigating Unit.
3. Under section 3(1)(a) of the said Act, I hereby appoint William Andrew Hofmeyr as head of the Special Investigating Unit.
4. The terms of reference of the Special Investigating Unit are to exercise or perform the powers, duties and functions assigned to or conferred upon a Special Investigating Unit by the said Act in respect of matters referred to it in terms of section 2(1)(a)(ii) of the said Act, and to investigate as contemplated in the said Act, any -
 - (a) serious maladministration in connection with the affairs of any State institution;
 - (b) improper or unlawful conduct by employees of any State institution;

- (c) unlawful appropriation or expenditure of public money or property;
- (d) unlawful, irregular or unapproved acquisitive act, transaction, measure or practice having a bearing upon State property;
- (e) intentional or negligent loss of public money or damage to public property;
- (f) corruption in connection with the affairs of any State institution; or
- (g) unlawful or improper conduct by any person which has caused or may cause serious harm to the interests of the public or any category thereof.

5. Under section 2(1)(b) of the said Act, I hereby establish a Special Tribunal to adjudicate upon justiciable civil disputes emanating from any investigation of the Special Investigating Unit established under paragraph 2 of this Proclamation.

6. The Special Investigating Unit established under paragraph 2 of this Proclamation shall continue to investigate all the matters which were referred to the Special Investigating Unit established by Proclamation No. R. 24 of 14 March 1997, including those matters referred to it by the said Proclamation and the Proclamations mentioned in the Schedule. Any reference in paragraph 3 of the Proclamations set out in the Schedule to "Proclamation No. R. 24 of 14 March 1997", must be interpreted as a reference to this proclamation.

WET OP SPESIALE ONDERSOEKEENHEDE EN SPESIALE TRIBUNALE, 1996
(WET No.74 OF 1996)

1. Proklamasie No. R. 14 van 14 Maart 1997, soos gewysig by Proklamasie No. R.72 van 11 November 1997 en Proklamasie No. R. 42 van 28 April 1998, word hierby herroep.
2. Kragtens artikel 2(1)(a) van die Wet op Spesiale Ondersoekeenhede en Spesiale Tribunale, 1996 (Wet No. 74 van 1996), stel ek 'n Spesiale Ondersoekeenheid aan.
3. Kragtens artikel 3(1)(a) van die genoemde Wet, stel ek hierby William Andrew Hofmeyr as hoof van die Spesiale Ondersoekeenheid aan.
4. Die opdrag van die Spesiale Ondersoekeenheid is om die bevoegdhede, pligte en werksaamhede wat deur gemelde Wet aan 'n Spesiale Ondersoekeenheid toegewys of opgedra word, uit te oefen of te verrig aangaande die aangeleenthede wat kragtens artikel 2(1)(ii) van die gemelde Wet na dit verwys is, en om soos beoog in gemelde Wet, onderzoek in te stel na enige -
 - (a) ernstige wanadministrasie in verband met aangeleenthede van enige Staatsinstelling;
 - (b) onbehoorlike of onregmatige optrede deur werknemers van enige sodanige

Staatsinstelling;

- (c) onregmatige bewilliging of besteding van publieke geld of eiendom;
 - (d) onwettige, onreëlmataige of nie-goedgekeurde verkrygende handeling, transaksie, maatreël of praktyk wat betrekking het op Staatseiendom;
 - (e) opsetlike of nalatige verlies van publieke geld of skade aan publieke eiendom;
 - (f) korupsie in verband met die sake van enige Staatsinstelling; of
 - (g) onwettige of onbehoorlike optrede deur enige persoon wat ernstige benadeling vir die belang van die publiek of enige kategorie daarvan veroorsaak het of kan veroorsaak,
5. Kragtens artikel 2(1)(b) van die genoemde Wet, stel ek hierby 'n Spesiale Tribunaal aan om beregbare siviele geskille wat voortspruit uit enige ondersoek van die Spesiale Ondersoekeenheid wat ingestel is kragtens artikel 2 van hierdie Proklamasie, te bereg.

6. Die Spesiale Ondersoekeenheid aangestel kragtens paragraaf 2 van hierdie Proklamasie sal voortgaan om alle aangeleenthede te ondersoek wat verwys is na die Spesiale Ondersoekeenheid wat aangestel is by Proklamasie No. R. 24 van 14 Maart 1997, insluitende daardie aangeleenthede wat na dit verwys deur die bedoelde Proklamasie en die Proklamasies vermeld in die Bylae. Enige verwysing in paragraaf 3 van die Proklamasies uiteengesit in die Bylae na "Proklamasie R. 24 van 14 Maart 1997", moet geinterpreteer word as 'n verwysing na hierdie proklamasie.






