MILITARY VETERANS' AFFAIRS ACT, 1999 (ACT No. 17 OF 1999)

REGULATIONS ON MILITARY VETERANS' AFFAIRS, 2001

The Minister of Defence has under section 16 of the Military Veterans' Affairs Act, 1999 (Act No. 17 of 1999), made the Regulations in the Schedule.

SCHEDULE**REGULATIONS ON MILITARY VETERANS' AFFAIRS, 2001****Definitions**

1. In these Regulations "the Act" means the Military Veterans' Affairs Act, 1999 (Act No. 17 of 1999), and, unless the context otherwise indicates, any word or expression to which a meaning has been assigned in the Act has that meaning.

Requirements and conditions in respect of dependants of military veterans

2. A dependant must comply with the following further requirements and conditions as envisaged in section 1 (v) (c) of the Act:

- (a) The person must be wholly or partially financially or otherwise dependent upon the relevant military veteran and must be a member of the household of that military veteran or, where the military veteran is deceased, that person must remain a member of the household after such decease; and
- (b) a person who claims that he or she is a dependant child or spouse of a military veteran must have qualified as such in terms of any provision of a law relating to the South African National Defence Force and dealing with dependants of members of that Force and which applied to the military veteran immediately prior to the date on which the military veteran became a military veteran or, if the person is born or is legally adopted or becomes a spouse, as the case may be, on or after such date, would have qualified as such had the person been born or legally adopted, or become a spouse, before such date.

Format and requirements of development programmes

3. (1) All development programmes which the Office formulates in terms of the Act must—
 - (a) be drafted in a clearly legible and understandable written form and shall carry a file number and be properly dated;
 - (b) be drafted in a systematic logical sequence and must at least contain—
 - (i) an introduction concisely summarising the military veterans' affairs, particularly the entitlements (if any), dealt within the programme, with reference to all policy decisions and relevant statutory provisions or administrative practices dealing with the matter;
 - (ii) a statement of the needs, disparities, inequalities or discriminatory aspects, if any, pertaining to the current administrative or statutory regulation of the military veterans' affairs to be dealt with; and
 - (iii) a recommendation, if any, of those administrative or legislative steps to be taken to address, alleviate or resolve the current situation contemplated in subparagraph (ii) above, and a suggested time-frame for the carrying out thereof.
- (2) For the purpose of this regulation, programmes, in connection with military veterans' affairs, include at least—
 - (a) reparation programmes, with reference to entitlements, income support and housing assistance;
 - (b) health care programmes, with reference to disablements, disabilities, injuries and illnesses, medical care, rehabilitation, and aged, retirement and general health care;
 - (c) occupational programmes, including counselling, career assessment, vocational support, re-education, training and funding assistance as regards resettlement and employment provisioning; and
 - (d) military heritage programmes.

Recognition of Military Veterans' Organisations

4. (1) Any organisation or association established in respect of military veterans in the private sector and which wishes to be recognised by the Minister of Defence as lawfully representative of interests of military veterans for the purposes of the Act, must in writing furnish the Office with—

- (a) a copy of its constitution, containing details of its nature and objects;
- (b) full details of its office bearers; and
- (c) the total number of military veterans it represents.

(2) The Office must, after a full investigation, make recommendations to the Chief of the South African National Defence Force and the Minister in respect of the recognition of any organisation or association referred to in subregulation (1), and the Minister may thereafter recognise such an organisation or association as lawfully representative of the interests of the military veterans concerned, by advising the organisation or association concerned in writing thereof at its official head office address.

(3) If the Minister refuses to recognise a military veterans' organisation or association as contemplated in subregulation (2), the relevant organisation or association may appeal to the President as Patron-in-Chief of all military veterans, and whose decision on the matter is final.

Nomination procedures for Advisory Board members

5. (1) The procedure for the nomination by recognised military veterans' organisations of members of the Advisory Board, as contemplated in section 7 (2) of the Act, is as follows:

- (a) The Office must, in writing, invite all recognised military veterans' organisations to submit nominations for the appointment of the Chairperson and the members of the Advisory Board.
- (b) Every recognised military veterans' organisation may nominate in writing and within a period of three months after receipt of the invitation referred to in paragraph (a), at least one but not more than four persons for any such appointment.
- (c) The organisation must, after consulting with such nominee, furnish the Office with—
 - (i) full written personal and career particulars of every nominee;
 - (ii) full reasons and motivation for the nomination;
 - (iii) the written and signed acceptance of the nomination by every nominee.

(2) The Office must forward a full report on all nominations and information received, together with motivated recommendations by the Office of particular nominees for appointment, to the Chief of the South African National Defence Force, who must forward the documentation received together with his or her own recommendations to the Secretary for Defence for submission to the Minister who must appoint the Chairperson and members of the Advisory Board.

(3) The Minister must, in writing, inform—

- (a) every recognised military veterans' organisation which has submitted a nomination to the Office; and
- (b) any person so appointed,

of any appointment so made by the Minister in terms of subregulation (2).

Short title and commencement

6. These Regulations shall be called the Regulations on Military Veterans' Affairs, 2001, and come into operation on the date of commencement of the Act.

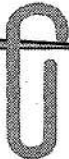
