**AMENDMENT OF THE RULES REGULATING THE PROCEEDINGS OF THE
TRANSVAAL PROVINCIAL DIVISION AND THE WITWATERSRAND LOCAL
DIVISION OF THE HIGH COURT OF SOUTH AFRICA.**

Notice is hereby given that the Judge President of the Transvaal Provincial Division of the High Court of South Africa has, in terms of section 43(2)(b) of the Supreme Court Act, 1959 (Act 59 of 1959), amended the rules regulating the proceedings of the Transvaal Provincial Division and the Witwatersrand Local Division of the High Court of South Africa, by:-

- (a) The substitution for rule 1 of the following rule:-

"Terms

In the Transvaal Provincial Division and the Witwatersrand Local Division the terms for the dispatch of civil and criminal business shall be as follows:-

(1) For the year 2003

- (a) The first term shall be from 27 January to 11 April, inclusive;
- (b) The second term shall be from 29 April to 27 June, inclusive;

- (c) The third term shall be from 4 August to 26 September, inclusive and;
- (d) The fourth term shall be from 6 October to 5 December, inclusive.

(2) For the year 2004

- (a) The first term shall be from 26 January to 8 April, inclusive;
- (b) The second term shall be from 19 April to 18 June, inclusive;
- (c) The third term shall be from 26 July to 23 September, inclusive and;
- (d) The fourth term shall be from 4 October to 3 December, inclusive.

(3) For the year 2005

- (a) The first term shall be from 24 January to 24 March, inclusive;
- (b) The second term shall be from 4 April to 15 June, inclusive;
- (c) The third term shall be from 25 July to 23 September; inclusive; and

(d) The fourth term shall be from 3 October to 2 December, inclusive".

(b) **The substitution for rule 2 of the following rule:-**

"ADMINISTRATIVE RECESSES

(1) The Administrative recesses for the year 2003 shall be as follows:-

- (a) from 12 April to 28 April 2003, inclusive;
- (b) from 28 June to 3 August 2003, inclusive;
- (c) from 27 September to 5 October 2003, inclusive; and
- (d) from 6 December 2003 to 24 January 2004, inclusive.

(2) The Administrative recessed for the year 2004 shall be as follows:-

- (a) from 9 April to 18 April 2004, inclusive;
- (b) from 19 June tot 25 July 2004, inclusive;
- (c) from 24 September to 3 October 2004, inclusive; and
- (d) from 4 December 2004 to 24 January 2005, inclusive.

(3) The Administrative recessed for the year 2005 shall be as follows:-

- (a) from 25 March to 3 April 2005, inclusive;
- (b) from 16 June to 24 July 2005, inclusive;
- (c) from 24 September to 2 October 2005, inclusive; and
- (d) from 3 December to 23 January 2006.

(4) The Judge President shall determine prior to the commencement of the recesses referred to in sub rules (1), (2) and (3) how many and which judges are to perform the functions in the said divisions during the recesses.

(5) No civil or criminal business shall be heard or placed on the roll for hearing during the following terms unless a judge on duty, as referred to in sub rule (4), is of the opinion that the business is urgent:-

- (a) from 20 December 2003 to 4 January 2004, inclusive;
- (b) from 24 December 2004 to 2 January 2005, inclusive; and
- (c) from 23 December 2005 to 1 January 2006, inclusive."

Notice is hereby given that the Judge President of the Transvaal Provincial Division of the High Court of South Africa and also as the Acting Judge of the High Court of Venda has, in terms of section 43(2)(b) of the Supreme Court Act, 1959 (Act 59 of 1959), amended the rules regulating the proceedings of the High Court of Venda, by:-

- (a) The substitution for rule 1 of the following rule:-

"Terms

In the High Court of Venda the terms for the dispatch of civil and criminal business shall be as follows:-

(1) **For the year 2003**

- (a) The first term shall be from 27 January to 11 April, inclusive;
- (b) The second term shall be from 29 April to 27 June, inclusive;
- (c) The third term shall be from 4 August to 26 September, inclusive and;

- (d) The fourth term shall be from 6 October to 5 December, inclusive.

(2) **For the year 2004**

- (a) The first term shall be from 26 January to 8 April, inclusive;
- (b) The second term shall be from 19 April to 18 June, inclusive;
- (c) The third term shall be from 26 July to 23 September, inclusive
and;
- (d) The fourth term shall be from 4 October to 3 December,
inclusive.

(3) **For the year 2005**

- (a) The first term shall be from 24 January to 24 March, inclusive;
- (b) The second term shall be from 4 April to 15 June, inclusive;
- (c) The third term shall be from 25 July to 23 September; inclusive;
and
- (d) The fourth term shall be from 3 October to 2 December,
inclusive".

(b) **The substitution for rule 2 of the following rule:-**

"ADMINISTRATIVE RECESSES

(1) The Administrative recesses for the year 2003 shall be as follows:-

- (a) from 12 April to 28 April 2003, inclusive;
- (b) from 28 June to 3 August 2003, inclusive;
- (c) from 27 September to 5 October 2003, inclusive; and
- (d) from 6 December 2003 to 24 January 2004, inclusive.

(2) The Administrative recessed for the year 2004 shall be as follows:-

- (a) from 9 April to 18 April 2004, inclusive;
- (b) from 19 June tot 25 July 2004, inclusive;
