**AMENDMENT OF THE RULES REGULATING THE PROCEEDINGS OF
THE TRANSVAAL PROVINCIAL DIVISION AND THE
WITWATERSRAND LOCAL DIVISION OF THE HIGH COURT OF
SOUTH AFRICA**

Notice is hereby given that the Judge President of the Transvaal Provincial Division of the High Court of South Africa has, in terms of section 43(2)(b) of the Supreme Court Act, 1959 (Act No. 59 of 1959), amended the rules regulating the proceedings of the Transvaal Provincial Division and the Witwatersrand Local Division of the High Court of South Africa, by the substitution for rule 7(5) of the following rule:

“7(5) Every party to an action who receives notice of the trial date shall forthwith, and in any event not later than seven days after receipt of such a notice, give notice in writing to every other party or his or her attorney of the date which was allocated by the registrar for the hearing: Provided that the party receiving notice from the registrar need not give such notice to a party who is represented by the same attorney as the party who is so obliged to give notice.”.

Kennis word hierby gegee dat die Regter-President van die Transvaalse Provinsiale Afdeling van die Hoë Hof van Suid-Afrika die reëls waarby die verrigtinge van die Transvaalse Provinsiale Afdeling en die Witwatersrandse Plaaslike Afdeling van die Hoë Hof van Suid-Afrika gereël word, kragtens artikel 43(2)(b) van die Wet op die Hooggeregshof, 1959 (Wet No. 59 van 1959), gewysig het deur die vervanging van reël 7(5) deur die volgende reël:

“7(5) Elke party tot ‘n aksie wat kennis van die plasing van die saak vir verhoor ontvang, moet onverwyld, maar nie later nie as binne sewe dae daarna, skriftelike kennis aan elke ander party of sy of haar prokureur gee van die verhoordatum wat deur die griffier toegeken is: Met dien verstande dat sodanige kennis nie gegee hoef te word aan ‘n party wat verteenwoordig word deur dieselfde prokureur as die party wat so kennis moet gee nie.”.
