Terms of Reference:

- (2) Paragraph 1.2.1: Delete the words "Whether any of the transactions in question" and substitute therefor the words: "Involved any collusion on the part of any person or juristic entity".
- (3) Paragraph 1.3, first line: Insert a comma after the word "inquiry" and also after the word "whether".

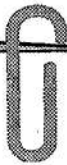

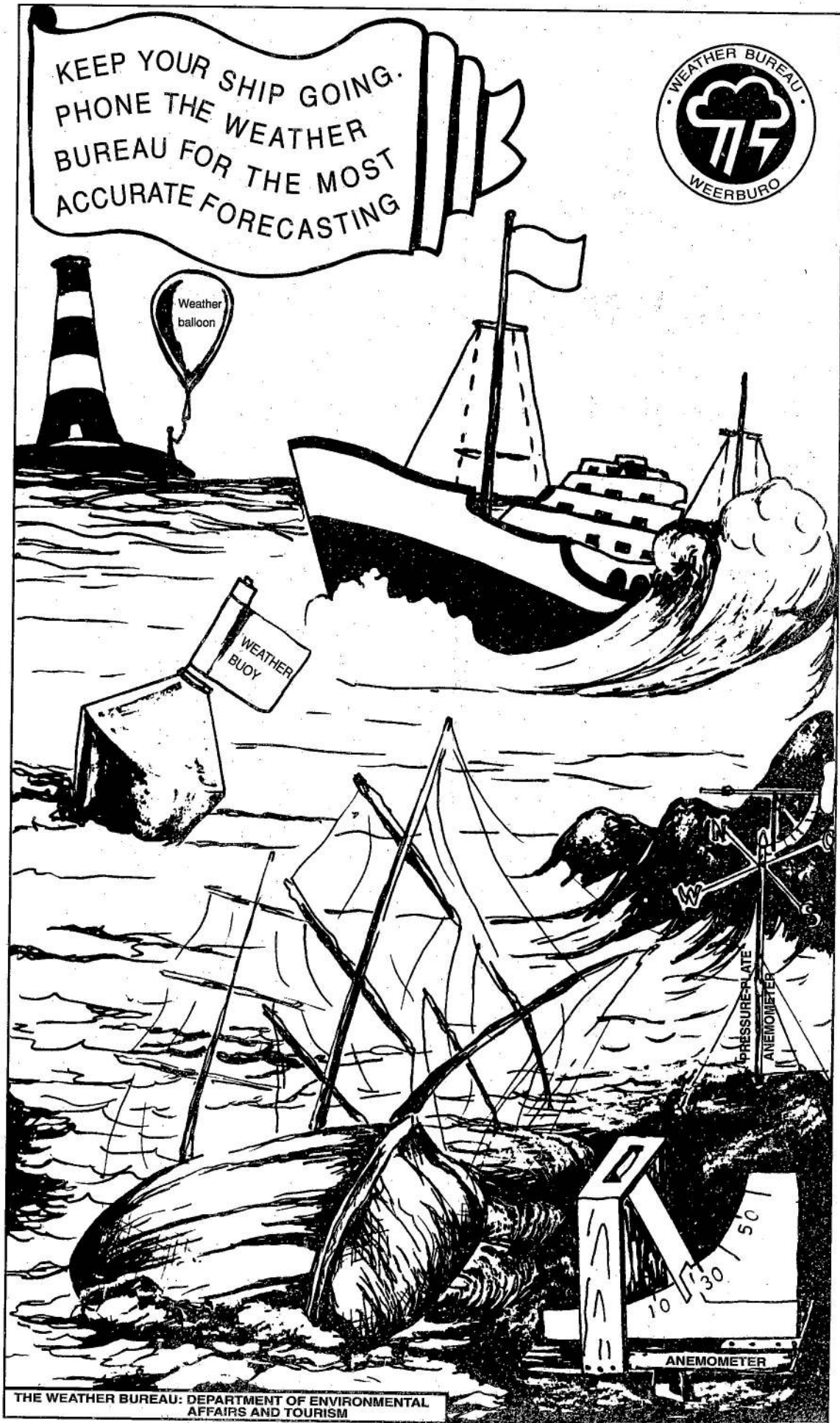

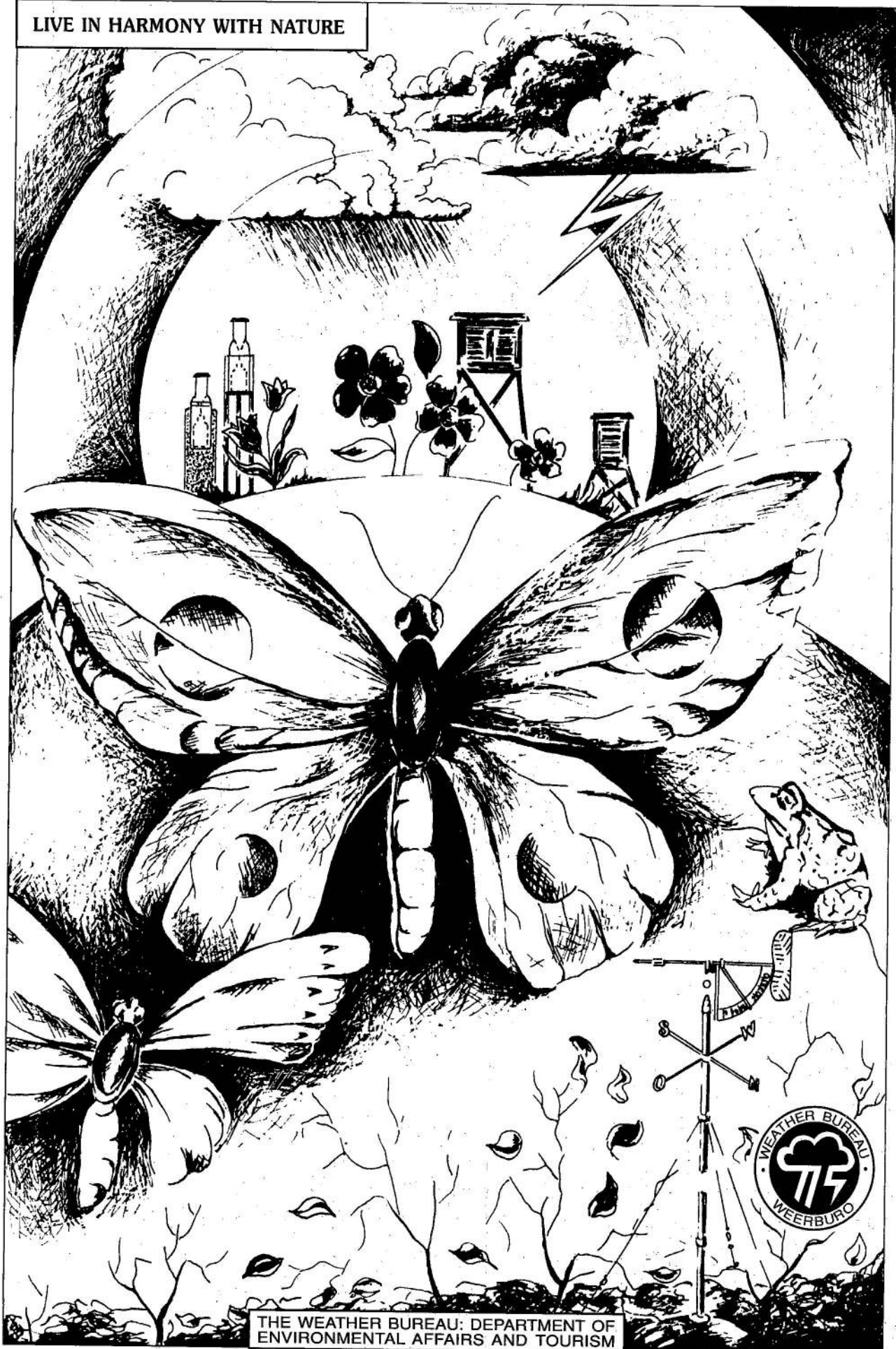
