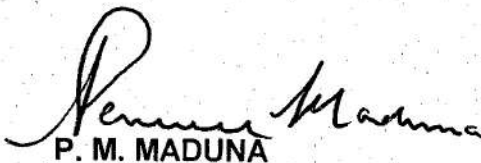
Definitions

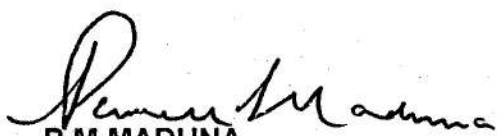
