AMENDMENT OF SCHEDULE 1 TO THE SOUTH AFRICAN REVENUE SERVICE ACT, 1997 (ACT NO. 34 OF 1997)

SCHEDULE

Schedule 1 to the South African Revenue Service Act, 1997 (Act No. 34 of 1997), is hereby amended—

- (a) by the deletion of item 18; and
- (b) by the addition of the following items:
 - “18. Uncertificated Securities Tax Act, 1998 (Act No. 31 of 1998)
 - 19. Demutualisation Levy Act, 1998 (Act No. 50 of 1998)
 - 20. Skills Development Levies Act, 1999 (Act No. 9 of 1999)
 - 21. Unemployment Insurance Contributions Act, 2002 (Act No. 4 of 2002)
 - 22. Any regulation, proclamation, government notice or rule issued in terms of the abovementioned legislation or any agreement entered into in terms of this legislation or the Constitution.”.
