No. R. 1201**26 September 2002****DECLARATION OF PEACE OFFICERS IN TERMS OF SECTION 334 OF THE CRIMINAL PROCEDURE ACT, 1977
(ACT No. 51 OF 1977)**

I, Abdullah Mohamed Omar, Acting Minister for Justice and Constitutional Development, acting under and by virtue of the powers vested in me by section 334 (1) (a) of the Criminal Procedure Act, 1977 (Act No. 51 of 1977), hereby—

- (1) amend Government Notice No. 23143 of 19 February 2002 by the substitution of Parts 4 (a) and 5 (b) of that Notice with the parts set out in the Schedule hereto; and
- (2) determine that—
 - (a) any power exercised or anything done in terms of parts 4 (a) and 5 (b) of Government Notice No. 23143 of 19 February 2002 and which can be done in terms of this Notice shall be deemed to have been exercised or done in terms of this Notice; and
 - (b) any certificate of appointment issued in terms of section 334 (2) (a) in accordance with any Notice previously issued in terms of section 334 (1) (a) of the Criminal Procedure Act, 1977 (Act No. 51 of 1977), which could be issued in accordance with this Notice, is deemed to have been issued on the basis of this Notice.
