FOODSTUFFS, COSMETICS AND DISINFECTANTS ACT, 1972
(ACT NO. 54 OF 1972)

REGULATIONS GOVERNING THE TOLERANCES FOR CERTAIN SEEDS IN
CERTAIN AGRICULTURAL PRODUCTS

The Minister of Health has, in terms of section 15(1) of the Foodstuffs, Cosmetics and Disinfectants Act, 1972 (Act No. 54 of 1972), made the regulations in the Schedule.

SCHEDULE

1. Definitions

In these regulations any expression to which a meaning has been assigned in the Act shall bear that meaning, and unless the context indicates otherwise –

“agricultural product” means barley, buckwheat, grain sorghum, groundnuts, maize, oats, oilseed rape (canola), rice, rye, soya beans, sunflower seed or wheat;

“plant species” means a plant bearing poisonous seeds and identified to be *Argemone mexicana* L., *Convolvulus* species, *Crotolaria* species, *Datura* species, *Ipomoea purpurea* Roth., *Lolium temulentum*, *Ricinis communis* or *Xanthium* species;

“the Act” means the Foodstuffs, Cosmetics and Disinfectants Act, 1972 (Act No. 54 of 1972).

2. Restrictions

(1) For the purpose of section 2(1)(a)(ii) of the Act, no agricultural product shall, subject to the provisions of subregulation (2), contain -

(a) seeds of *Crotalaria* species, *Datura* species or *Ricinis communis* in a measure greater than one seed per 1 000 g; and


(b) seeds of *Argemone mexicana* L., *Convolvulus* species, *Ipomoea purpurea* Roth., *Lolium temulentum* and *Xanthium* species in a measure greater than seven seeds per 1 000 g,

of that agricultural product.

(2) Notwithstanding the provisions of subregulation (1), where an agricultural product is to undergo sifting or any other process in order to reduce the number of poisonous seeds of any plant species before the sale thereof as a foodstuff for human consumption, these regulations shall only apply after such sifting or other process has taken place.

3. Repeal

The regulations published under Government Notice No. R. 1466 of 10 July 1987, as amended by Government Notice No. R. 854 of 29 April 1988, are hereby repealed.

**WET OP VOEDINGSMIDDELS, SKOONHEIDSMIDDELS EN
ONTSMETTINGSMIDDELS, 1972 (WET NO. 54 VAN 1972)**

**REGULASIES BETREFFENDE DIE TOLERANSIES VIR SEKERE SADE IN SEKERE
LANDBOUPRODUKTE**

Die Minister van Gesondheid het kragtens artikel 15(1) van die Wet op Voedingsmiddels, Skoonheidsmiddels en Ontsmettingsmiddels, 1972 (Wet No. 54 van 1972), die regulasies in die Bylae uitgevaardig.

BYLAE

1. Woordomsrywings

In hierdie regulasies het enige uitdrukking waaraan 'n betekenis in die Wet geheg is, daardie betekenis en, tensy uit die samehang anders blyk, beteken -

“die Wet” die Wet op Voedingsmiddels, Skoonheidsmiddels en Ontsmettingsmiddels, 1972 (Wet No. 54 van 1972);

“landbouprodukt” bokwiet, gars, graansorghum, grondboontjies, hawer, koring, mielies, oliesaadraap (canola), rog, rys, sojabone en sonneblomsaad;

“plantspesie” 'n plant wat toksiese sade dra en geïdentifiseer is as *Argemone mexicana* L., *Convolvulus*-spesie, *Crotolaria*-spesie, *Datura*-spesie, *Ipomoea purpurea* Roth., *Lolium temulentum*, *Ricinus communis* of *Xanthium*-spesie;

2. Beperkings

(1) Vir doeleindes van artikel 2(1)(a)(ii) van die Wet, mag geen landbouprodukt, behoudens die bepalings van subregulasie (2) -

(a) die sade van *Crotalaria*-spesie, *Datura*-spesie of *Ricinis communis* in groter mate bevat as een saad per 1 000 g; en


(b) die sade *Argemone mexicana* L., *Convolvulus*-spesie, *Ipomoea purpurea* Roth., *Lolium temulentum* and *Xanthium*-spesie in groter mate bevat as sewe sade per 1 000 g,

van daardie landbouprodukt nie.

(2) Ondanks die bepalings van subregulasie (1), waar 'n landbouprodukt sifting of enige ander proses sal ondergaan ten einde die getal toksiese sade van 'n plantspesie te verminder voor die verkoop daarvan as 'n voedingsmiddel vir menslike gebruik, is hierdie regulasies alleenlik van toepassing nadat sodanige sifting of ander proses plaasgevind het.


3. Herroeping
