#### MEDICINES AND RELATED SUBSTANCES ACT, 1965 (ACT NO. 101 OF 1965)

### **GENERAL REGULATIONS MADE IN TERMS ACT 101 OF 1965: AMENDMENT**

The Minister of Health has, in consultation with the executive committee of the Medicines Control Council, in terms of Section 35 (1) read together with section 35(8) of the Medicines and Related Substances Act, 1965 (Act No. 101 of 1965), made the regulations in the Schedule.

#### Definition

#### SCHEDULE

1. In this Schedule "the Regulations" means the General Regulations made in terms of Act 101 of 1965, published under Government Notice No. R 539 of 25 April 2003 and "the Act" means the Medicines and Related Substances Act, 1965 (Act No. 101 of 1965).

#### Amendment of regulation 18

2. Regulation 18 of the regulations is hereby amended-

- (a) in subregulation (3) by the deletion of paragraph (c);
- (b) by the insertion after subregulation (3) of the following subregulation and the existing subregulation (4) becoming subregulation (5)

"(4) The application referred to in subregulation (1) may be submitted even before a supplementary course as contemplated in section 22C of the Act is completed, but a licence may only be issued upon proof being furnished that such a course has been successfully completed and all the other requirements have been met."
