## GOVERNMENT NOTICE

### DEPARTMENT OF LABOUR

No. R. 730

#### **Skills Development Act, 1998 (ACT NO.97 OF 1998)**

#### **Regulations concerning the registration of intended learnerships and learnership agreements, 2001: Amendments**

The Minister of Labour has under Section 36 of the Skills Development, 1998 (Act No. 97 of 1998), and after consultation with the National Skills Authority, made the regulations in the Schedule.

### **SCHEDEULE**

#### **Definition**

1. In these regulations “the Regulations” means the Regulation No. 330, published in Government Gazette Notice No. 22197 on 3 April 2001.
2. **Amendment of Regulation 3 of the Regulations**

Regulation 3 of the Regulations is hereby amended by the substitution for sub-regulation (4) of the following sub-regulation :

- “(4) [A] Subject to any limits or conditions that the Director-General may determine, a SETA may only register a learnership agreement to which a group of employers is party if-
- (a) one of the employers is identified in the agreement as the lead employer; and
  - (b) the lead employer undertakes to ensure compliance with the employer’s duties in terms of the agreement.”
