#### SOUTH AFRICAN REVENUE SERVICE

CUSTOMS AND EXCISE ACT, 1964
AMENDMENT OF RULES (NO. DAR/2)

Under section 120 of the Customs and Excise Act, 1964, the rules published in Government Notice R.1874 of 8 December 1995 are amended to the extent set out in the Schedule hereto.

#### Schedule


- (a) By the substitution for the heading to the rules numbered 120B of the following heading:
  - "Procedures in respect of goods carried by road on the [Trans Kalahari] <u>prescribed route between the Republic of South Africa, the Republic of Botswana and the Republic of Namibia</u>"
- (b) By the substitution for paragraph (a) of rule 120B.01 of the following paragraph:
  - "(a) The provisions of these rules apply only-
    - in respect of goods carried by road [on the Trans-Kalahari Route] between the Republic of South Africa, the Republic of Botswana and the Republic of Namibia on the route prescribed in rule 120B.01(b)(ii); and
    - (ii) in the case of goods so carried from the Republic of South Africa, in respect of goods entered for such carriage at the office of the Controller for Johannesburg, Johannesburg International Airport, Germiston, Ramathlabama, [or] Skilpadshek or Kopfontein."
- (c) By the addition after rule 120B.01(b)(i)(bb) of the following subparagraph:
  - "(cc) Kopfontein, the place of exit or entry in the Republic of South Africa, is known as Tlokweng in the Republic of Botswana."

- (d) By the substitution for subparagraph (ii) of rule 120B.01(b) of the following subparagraph:
  - "(ii) the [Trans Kalahari Route] prescribed route means:
    - (aa) a route from the Republic of South Africa, starting in Johannesburg, <u>Johannesburg International</u> <u>Airport, or Germiston</u> exiting through <u>Kopfontein</u>, Ramathlabama or Skilpadshek, to Gaborone in the Republic of Botswana;
    - (bb) a route from the Republic of Botswana, starting in Gaborone, exiting through Tlokweng, Ramathlabama or Pioneersgate, to Johannesburg, Johannesburg International Airport, or Germiston in the Republic of South Africa;
    - (cc) a route from the Republic of South Africa, starting in Johannesburg, <u>Johannesburg International Airport or Germiston</u>, exiting through <u>Kopfontein</u>, Ramathlabama or Skilpadshek, through the Republic of Botswana and exiting through Mamuno to Walvis Bay or Windhoek in the Republic of Namibia;
    - (dd) a route from the Republic of Namibia, starting in Windhoek or Walvis Bay, exiting through Trans Kalahari and through the Republic of Botswana, exiting through <u>Tlokweng</u>, Ramathlabama or Pioneersgate to Johannesburg, <u>Johannesburg International Airport or Germiston</u> in the Republic of South Africa."
- (e) By the substitution for rule 120B.02 of the following rule:
  - "120B.02 Notwithstanding anything to the contrary in rule 120A.01 or any other rule the SAD 500, SAD 501, SAD 502 and SAD 503 must be used instead of form CCA1 for the purposes of any relevant customs and excise procedure regulating the movement of goods where such goods are carried by road from the Republic of South Africa on the [Trans Kalahari Route] prescribed route."
- (f) By the substitution for paragraph (b) of rule 120B.04 of the following paragraph:
  - "(b) (i) Notwithstanding these provisions, no person is absolved from complying with any other prescribed requirement, as may be applicable in each case, relating to the entry and removal in bond or entry for and export of the goods carried on the [Trans Kalahari Route] prescribed route; and
    - (ii) except with regard to the use of form CCA1 as specified in rule 120B.02, the provisions in the rules numbered 120A shall apply mutatis mutandis to the movement of any goods from the Republic to Botswana or the Republic of Namibia on the [Trans Kalahari] prescribed route [as contemplated in these rules]."
- (g) By the insertion after rule 120B.04(c)(ii) of the following rule:
  - "120B.05 Notwithstanding rule 120B.02, users of form CCA1 at Kopfontein may use existing stock until 30 April 2005."

(h) By the substitution in item 202.00, Prescribed Forms, of the following forms:


