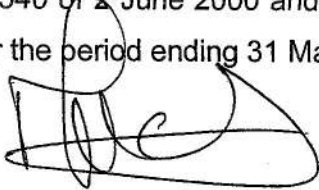

LABOUR RELATIONS ACT, 1995

ROAD FREIGHT INDUSTRY: RENEWAL OF PERIOD OF OPERATION OF THE EXEMPTIONS AND DISPUTE RESOLUTION AGREEMENT

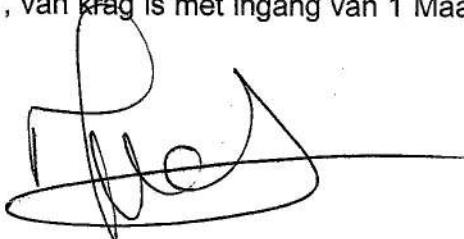
