CUSTOMS AND EXCISE ACT, 1964 AMENDMENT OF RULES (NO. DAR/104)

Under sections 15(1) and 120 of the Customs and Excise Act, 1964, the rules published in Government Notice R.1874 of 8 December 1995 are amended to the extent set out in the Schedule hereto.

PRAVIN JAMNADAS GORDHAN COMMISSIONER FOR THE SOUTH AFRICAN REVENUE SERVICE

SCHEDULE

- (a) By the substitution for rule 15.01 of the following rule:
 - Any person entering the Republic shall [not remove his baggage, nor any other goods accompanying him, from customs and excise control, or cause such baggage or goods to be so removed unless so authorized by the Controller and no person shall deliver any such baggage or goods left with or handed to him for delivery until release has been granted.] declare to a Controller on a form DA 331 all goods contemplated in section 15(1)(a)."
- (b) By the insertion after rule 15.02 of the following rule:
 - "15.03 No [goods brought into the Republic for commercial purposes, whether or not for own use, shall be entered in terms of the provisions of section 38.] person
 - (a) entering the Republic shall remove his or her baggage, or any other goods

 accompanying him or her, from customs and excise control, or cause such baggage
 or goods to be so removed unless so authorized by the Controller; and

- (b) shall deliver any such baggage or goods left with him or her or handed to him or her for delivery unless release has been granted."
- (b) By the insertion in item 202.00 of the Schedule to the Rules of the following form:
