CUSTOMS AND EXCISE ACT, 1964 AMENDMENT OF AIR PASSENGER TAX (APT/3)

Under the proviso to section 47B(2)(b)(i) of the Customs and Excise Act, 91 of 1964, I, Trevor Andrew Manuel, hereby amend the rate of the air passenger tax which was fixed in terms of Government Notice No. R. 952 of 27 June 2003 in respect of the carriage of any chargeable passenger departing on a flight from any airport in the Republic to a final destination in the Republic of Botswana, the Kingdom of Lesotho, the Republic of Namibia or the Kingdom of Swaziland, from R55 to R60.

This notice shall come into operation on **1 August 2005**, and shall apply to the carriage of a chargeable passenger on any flight that commences on or after that date and where the ticket of such passenger in respect of that flight was purchased and issued after the date of publication of this notice.

DOEANE- EN AKSYNSWET, 1964 WYSIGING VAN LUGPASSASIERSELASTING (LPB/3)

Kragtens die voorbehoudsbepaling by artikel 47B(2)(b)(i) van die Doeane- en Aksynswet, 91 van 1964, wysig ek, Trevor Andrew Manuel, hierby die koers van die lugpassasiersbelasting wat ingevolge Goewermentskennisgewing No. R. 952 van 27 Junie 2003 vasgestel is ten opsigte van die vervoer van enige belasbare passasier wat op enige vlug vertrek vanaf enige lughawe in die Republiek na 'n finale bestemming in die Republiek van Botswana, die Koninkryk van Lesotho, die Republiek van Namibië en die Koninkryk van Swaziland, van R55 na R60.

Hierdie kennisgewing tree op **1 Augustus 2005** in werking, en is van toepassing op die vervoer van 'n belasbare passasier op enige vlug wat 'n aanvang neem op of na daardie datum en waar die kaartjie van sodanige passasier ten opsigte van daardie vlug aangekoop en uitgereik is na die datum van publikasie van hierdie kennisgewing.
