### **PUBLIC FUNDING OF REPRESENTED POLITICAL PARTIES ACT, 1997 (ACT NO. 103 OF 1997): AMENDMENT OF REGULATIONS**

Under section 10 of the Public Funding of Represented Political Parties Act, 1997 (Act No. 103 of 1997), I, acting on the recommendations of a joint committee of the National Assembly and the National Council of Provinces, hereby make the regulations in the Schedule.

Given under my Hand and the Seal of the Republic of South Africa at Northern Cape on this Thirtieth day of August Two Thousand and Five.

## SCHEDULE

### Definitions

1. In this Schedule "the Regulations" means the regulations published under Government Notice No. R. 117 of 20 November 1998.

### Amendment of Regulation 5 of the Regulations

2. Regulation 5 of the Regulations is hereby amended—

(a) by the substitution for subregulation (1) of the following subregulation:

"(1) Subject to subregulation (3), all allocations to which a political party is entitled as determined in terms of regulations 3 and 4, must be paid to the political party in question in four equal instalments, each within three months of the previous payment. The first instalment must be paid within four weeks of the beginning of the financial year in question.";

and

(b) by the addition of the following subregulation:

"(3) (a) The Commission must, within ten days after the date on which the Speaker of a legislature has published the notice contemplated in item 5(3) of Schedule 6A to the Constitution, re-allocate in accordance with the provisions of regulations 3 and 4, as the case may be, fifty (50) per cent of the total amount of funding determined in terms of regulation 2(1) for the financial year in question to the political parties that,

at the expiry of the period referred to in item 5(3) of Schedule 6A to the Constitution, qualify for the allocation of moneys from the Fund in terms of section 5 of the Act.

(b) All allocations to which a political party is entitled in terms of paragraph (a), must be paid to the political party in question in two equal instalments. The first instalment must be paid within the first fifteen days of October and the second instalment must be paid within the first fifteen days of January of the financial year in question.".

### **Amendment of Regulation 8 of the Regulations**

3. Regulation 8 of the Regulations is hereby amended by the substitution for subregulation (2) of the following subregulation:

"(2) The information required for the purposes of subregulation (1) must be furnished to the Commission—

- (a) by the accounting officer referred to in section 6(1) of the Act within three months after the end of the financial year in question; or
- (b) in the case of a political party contemplated in section 6A(3) of the Act, by the person who last held the office of accounting officer referred to in section 6(1) of the Act of that party or, if he or she is not available, the leader of that party within two months after the date on which a party is required to close its books and records of account in terms of section 6A(4) of the Act."

### **WET OP DIE OPENBARE BEFONDSING VAN VERTEENWOORDIGDE POLITIEKE PARTYE, 1997 (WET NO. 103 VAN 1997): WYSIGING VAN REGULASIES**

Kragtens artikel 10 van die Wet op die Openbare Befondsing van Verteenwoordigde Politieke Partye, 1997 (Wet No. 103 van 1997), en handelende op aanbevelings van 'n gesamentlike komitee van die Nasionale Vergadering en die Nasionale Raad van Provincies, vaardig ek hierby die regulasies in die Bylae uit.

**BYLAE****Woordomskrywing**

1. In hierdie Bylae beteken "die Regulasies" die regulasies kragtens Goewermentskennisgewing No. R. 117 van 20 November 1998 gepubliseer.

**Wysiging van Regulasie 5 van die Regulasies**

2. Regulasie 5 van die Regulasies word hierby gewysig—
- (a) deur subregulasie (1) deur die volgende subregulasie te vervang:
- "(1) Behoudens subregulasie (3), moet al die toekennings waarop 'n politieke party geregtig is soos bepaal ingevolge regulasies 3 en 4, aan die betrokke politieke party in vier gelyke paaiemende betaal word, elkeen binne drie maande vanaf die vorige betaling. Die eerste paaiment moet binne vier weke vanaf die begin van die betrokke boekjaar betaal word.>"; en
- (b) deur die volgende subregulasie by te voeg:
- "(3) (a) Die Kommissie moet, binne tien dae na die datum waarop die Speaker van 'n wetgewer die kennisgewing beoog in item 5(3) van Bylae 6A by die Grondwet publiseer, ooreenkomsdig die bepalings van regulasies 3 en 4, na gelang van die geval, vyftig (50) persent van die totale bedrag van befondsing wat ingevolge regulasie 2(1) bepaal word vir die betrokke boekjaar, hertoeken aan die politieke

partye wat by verstryking van die tydperk bedoel in item 5(3) van Bylae 6A by die Grondwet, vir die toekenning van geld vanuit die Fonds ingevolge artikel 5 van die Wet kwalifiseer.

(b) Alle toekennings waarop 'n politieke party ingevolge paragraaf (a) geregtig is, moet aan die betrokke politieke party in twee gelyke paaiemente betaal word. Die eerste paaiement moet binne die eerste vyftien dae van Oktober betaal word en die tweede paaiement moet binne die eerste vyftien dae van Januarie van die betrokke boekjaar betaal word."

### **Wysiging van Regulasie 8 van die Regulasies**

3. Regulasie 8 van die Regulasies word hierby gewysig deur subregulasie (2) deur die volgende subregulasie te vervang:

"(2) Die inligting wat vir die doeleindes van subregulasie (1) vereis word, moet aan die Kommissie verskaf word—  
(a) deur die rekenpligtige beampte bedoel in artikel 6(1) van die Wet binne drie maande na die einde van die betrokke boekjaar; of  
(b) in die geval van 'n politieke party beoog in artikel 6A(3) van die Wet, deur die persoon wat laaste die amp van rekenpligtige beampte bedoel in artikel 6(1) van die Wet van daardie party beklee het of, indien hy of sy nie beskikbaar is nie, die leier van daardie party, binne twee maande na die datum waarop 'n party vereis word om sy rekeningboeke en rekeningkundige rekords ingevolge artikel 6A(4) van die Wet af te sluit."
